BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 302A-1509, Hawaii Revised Statutes, is
 amended to read as follows:

12 (1) To clean hard surfaces in bathrooms such as counters,

Description:

Requires the department of education to give first preference to environmentally-sensitive cleaning and maintenance products that carry the design for the environment label designated by the United States Environmental Protection Agency for use in public schools.

JUSTIFICATION SHEET

DEPARTMENT: Office of the Governor

TITLE: A BILL FOR AN ACT RELATING TO ENVIRONMENTALLY SENSITIVE PRODUCTS.

PURPOSE: Requires the Department of Education to give first preference to environmentally sensitive cleaning products that are approved by the Design for the Environment (DfE) program of the United States Environmental Protection Agency (EPA), rather than products approved by the Green Seal program.

MEANS: Amend sections 302A-1509 and 321-26.5, Hawaii Revised Statutes (HRS).

JUSTIFICATION: By Act 13, First Special Session Laws of Hawaii 2009, required the Department of Education to give first preference to cleaning products used in public schools that were certified to be environmentally sensitive by the Green Seal program.

This bill amends that law to replace the EPA as the designating authority on "green" cleaning products that should be used in public schools.

The DfE program is administered by the U.S. Environmental Protection Agency's Office of Pollution Prevention and Toxics, which has regulated chemicals for more than 30 years and has unique expertise in understanding the impacts of chemicals on people and the environment. The DfE has a scientific review team screen each ingredient for potential human health and environmental effects and that - based on currently available information, EPA predictive models, and expert judgment-the product contains only those ingredients that pose the least concern among chemicals in their class. The Legislature should utilize scientific data and processes from federal agencies when creating procurement preferences for state agencies in order to ensure accuracy and consistency.

Impact on the public: Ensures that the information that is being used for procurement preferences by the Department of Education is based on scientifically reliable information provided by the federal Environmental Protection Agency.

Impact on the department and other agencies: Enables the Department of Education and Department of Health to utilize reliable information provided by a federal agency.
