A BILL FOR AN ACT

RELATING TO CORRECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 353-10, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§353-10 [Reentry intake] Intake and reentry service
- 4 centers. There shall be within the department of public safety,
- 5 [a] an intake and reentry [intake] service center division for
- 6 adults in each of the counties, to screen, evaluate, and
- 7 classify the admission of persons to community correctional
- 8 centers and to provide for the successful reentry of persons
- 9 back into the community. Each center shall be directed and
- 10 managed by a manager and shall be staffed by a team of
- 11 psychiatrists, social workers, technicians, and other personnel
- 12 as may be necessary. The director of public safety may appoint
- 13 full-time or part-time professional and clerical staff or
- 14 contract for professional services to carry out the duties of
- 15 the centers as identified in this section.
- 16 The centers shall:
- 17 (1) Provide orientation, quidance, and technical services;

3	(10) Work closely and collaborate with the corrections
4	program services division."
5	SECTION 2. Act 24, First Special Session Laws of Hawaii
6	2009, is amended by amended section 3 to read as follows:
7	"SECTION 3. (a) Effective January 1, 2010, there is
8	established within the department of public safety a reentry
9	commission to work with the department in monitoring and
10	reviewing the comprehensive offender reentry program, including
11	facility educational and treatment programs, rehabilitative
12	services, work furloughs, and the Hawaii paroling authority's
13	oversight of parolees. The reentry commission may make
14	recommendations to the department, the Hawaii paroling authority,
15	and the legislature regarding reentry and parole services.
16	(b) The reentry commission shall consist of eleven members
17	who shall be appointed by the governor in accordance with section
18	26-34, Hawaii Revised Statutes, as follows:
19	(1) [Four] Five members shall be selected by the governor;
20	provided that at least one of the four shall be a
21	former inmate and none shall be government employees;

1	(2) Two members shall be selected by the president of the
2	senate;
3	(3) Two members shall be selected by the speaker of the
4	house of representatives;
5	[(4) One member shall represent the American Civil Liberties

8	on Prisons; and
9	[6] One member shall be a former inmate who has
10	successfully been reintegrated into the community.
11	(c) The reentry commission shall meet at least quarterly
12	and members shall serve without compensation, but may be
13	reimbursed for expenses, including travel expenses that are
14	necessary for the performance of their duties.
15	(d) The commission shall cease to exist on July 1, 2014."

PURPOSE:

to remove the member representing the American Civil Liberties Union from the

Reentry Commission.

MEANS:

Amend section 353-10, Hawaii Revised Statutes, and section 3 of Act 24, First Special Session Laws of Hawaii 2009.

JUSTIFICATION:

The division of the Department of Public Safety that was renamed in Act 24, First Special Session Laws of Hawaii 2009, was not accurate and the "Intake and Reentry Service Center Division" is a more accurate name for the duties performed by this division. member representing the American Civil Liberties Union on the Department of Public Safety's Reentry Commission (Commission) could easily encounter a conflict of interest by participating on the Commission, learning of a situation within Public Safety that in turn is litigated by the American Civil Liberties Union. By deleting the member from the Commission, the potential conflict will be avoided.

Impact on the public: There should be no impact on the public as this measure will simply rename a division and delete a member from a commission.

Impact on the department and other agencies: This bill will assist the department by having one of its divisions named appropriately and also eliminating the potential for a conflict of interest. Page 2
