A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that section 37-52.3, 2 Hawaii Revised Statutes, requires a special fund to reflect a 3 clear nexus between the benefits sought and the charges made 4 upon the users or beneficiaries of the program, as opposed to 5 serving primarily as a means of providing the program or users 6 with an automatic stream of support that is removed from the 7 normal budget and appropriations process.

8 The legislature further finds that there is a need to 9 clarify the nexus between the benefits sought and charges made 10 upon the users and beneficiaries of the environmental health 11 education fund. The fund is the depository of fees collected by 12 the department of health for permits, licenses, inspections, 13 various certificates, variances, investigations, and reviews 14 respecting:
