A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the University of
 Hawaii receives over \$400,000,000 in grants every year, yet
 receives only minimal funds from commercialization revenue and
 royalties. The purpose of this Act is to establish a task force
 to develop a strategic plan to increase the commercialization of
 the research conducted by the University of Hawaii.

7 SECTION 2. (a) There is established a task force to 8 develop a strategic plan to increase the commercialization of 9 the University of Hawaii's research. The task force shall 10 develop a plan that includes strategic goals, action steps, and 11 guidelines, which are derived, in part, from best practices.

12 (b) The task force shall consist of the following eleven13 members:

- 14 (1) Four members appointed by the president of the
 15 University of Hawaii, three of whom shall be from the
 16 University of Hawaii;
- 17 (2) Chief executive officer of the high technology18 development corporation;

20		plan and any proposed legislation, no later than
21		twenty days prior to the convening of the regular
22		session of 2011; and
