A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Article IX, sections 7 and 9 of the Hawaii 2 Constitution and chapter 6E, Hawaii Revised Statutes (HRS), demonstrate recognition of the importance of historic and 3 4 cultural resources to the State. Chapter 6E, HRS, authorizes 5 the creation of a comprehensive historic preservation program within the department of land and natural resources (DLNR) to 6 7 promote the conservation and use of historic and cultural 8 properties in Hawaii for the education, inspiration, pleasure, 9 and enrichment of its citizens.

10 DLNR's historic preservation division (division) is 11 entrusted with, among other things:

- 12 (1) Preserving historic property listed on the Hawaii
 13 Register of Historic Places;
- 14 (2) Coordination of the evaluation and management of
 15 burial sites, many of which contain native Hawaiian
 16 skeletal remains;
- 17 (3) Preserving and protecting historic sites on public
 18 lands designated as historic preserves;

1	(4)	Maintaining an inventory of more than thirty-eight	
2		thousand historic sites throughout the state;	
3	(5)	Providing the public and governmental agencies with	
4		technical information and assistance relating to	
5		historic preservation programs and processes; and	
6	(6)	Offering archaeological services to help other	
7		governmental agencies fulfill their historic	
8		preservation responsibilities.	
9	The division is also required to review numerous proposed		
10	project plans for compliance with the historic preservation laws		
11	relating to historic artifacts and burial sites.		
12	However, the legislature finds that the division has been		
13	under harsh criticism in recent years since about 2003, for its		
14	handling of historic sites and ancient remains, including		
15	improper re-interment and preservation of historic artifacts and		
16	boxes of iwi or burial remains, and the bulldozing and		
17	desecration of Hawea heiau in Hawaii Kai that was discovered in		
18	June 2009	. There have also been issues with and statements of	
19	missing archaeological reports and the lack of an up-to-date		
20	inventory of historic sites, which need to be investigated.		
21	The division has also experienced management and staffing

1 not yet been filled. As of August 2009, the division, including 2 its neighbor island offices, was understaffed, with no more than 3 fourteen employees and seven vacant positions, resulting in a backlog of paperwork that has stalled projects and continues to 4 5 pose problems for developers, archaeologists, the community, and 6 ultimately the state's economy. Additionally, the legislature 7 has heard of issues partly to do with a lack of accountability 8 in securing and expending state and federal funds. If the 9 division fails to meet federal mandates, the State risks losing 10 the associated federal funds.

In short, the division has immense responsibility withoutthe necessary staffing and fiscal resources.

13 The purpose of this Act is to require the auditor to 14 conduct a management audit of the division to examine the 15 effectiveness of programs and the efficiency of the agency. 16 SECTION 2. The auditor shall conduct a management audit of 17 the state historic preservation division of the department of 18 land and natural resources. The audit shall examine and assess:

- 19 (1) Compliance with state and federal mandates;
- 20 (2) Information management;

21 (3) The backlog of paperwork and services;

19	directly impacted by and depend on the division's mandated	
20	services.	

The auditor shall submit its findings and recommendations,including any proposed legislation, to the legislature no later

than twenty days prior to the convening of the regular session
 of 2011.

3 SECTION 3. This Act shall take effect upon its approval.
