A BILL FOR AN ACT

RELATING TO PUBLIC PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that state and local 2 spending on public works projects and construction procurement 3 drives a significant portion of Hawaii's economy. However, 4 because of Hawaii's higher cost of living, state contractors 5 often find it cheaper to employ nonresidents to work on public 6 works projects and construction procurement contracts. As a result, Hawaii residents face difficulties acquiring employment 7 8 in this important sector of the Hawaiian economy. Furthermore, 9 non-resident employees working on public works projects and 10 construction procurement contracts contribute very little to the 11 State's economy while they work in Hawaii, and return a 12 disproportionately large amount of their wages to their home 13 states upon the completion of their employment in Hawaii. 14 The legislature further finds that the inability of state 15 residents to acquire employment on public works projects and 16 construction procurement contracts contributes to unemployment 17 in the State, deprives the State of fiscal resources and 18 capital, and dampens the State's economic development.



- 1 intent of this Act is to level the playing field for Hawaii
- 2 residents and to remedy the negative effects of nonresident
- 3 employment on public works projects and construction procurement
- 4 contracts, while preserving contractors' flexibility to employ
- 5 nonresidents where necessary.
- 6 The purpose of this Act is to require that state residents
- 7 comprise eighty per cent of the labor force working on some
- 8 public works projects and construction procurement contracts.
- 9 SECTION 2. The Hawaii Revised Statutes is amended by
- 10 adding a new chapter to be appropriately designated and to read
- 11 as follows:
- 12 "CHAPTER
- 13 EMPLOYMENT OF STATE RESIDENTS ON PUBLIC WORKS PROJECTS AND
- 14 CONSTRUCTION PROCUREMENT CONTRACTS
- 15 § -A Definitions. As used in this chapter:
- "Contract" means public works contracts under chapter 103
- 17 and contracts for construction under chapter 103D.
- 18 "Contractor" shall have the same meaning as in section
- 19 103D-104 and as the term is applied to public works contracts
- 20 under chapter 103; provided that "contractor" includes a
- 21 subcontractor where applicable.

- 1 "Construction" shall have the same meaning as in section
- 2 103D-4 and includes public works and contracts under chapter
- **3** 103.
- 4 "Procurement officer" shall have the same meaning as in
- 5 section 103D-4, and as used for purposes of chapter 103.
- 6 "Resident" means a person who is physically present in the
- 7 State at the time the person claims to have established the
- 8 person's domicile in the State and shows the person's intent is
- 9 to make Hawaii the person's primary residence.
- 10 § -B Application of chapter. (a) This chapter shall
- 11 apply to all public works contracts under chapter 103 and to all
- 12 construction procurements under chapter 103D; provided that this
- 13 chapter shall not apply to procurements for professional
- 14 services under section 103D-304 and procurements for small
- 15 purchases under chapter 103D-305.
- 16 (b) This chapter shall apply to any subcontract of \$50,000
- 17 or more in connection with any general contract otherwise
- 18 covered by this chapter.
- 19 § -C Requirements of contractor. (a) A contractor
- 20 awarded any contract shall ensure that Hawaii residents comprise
- 21 not less than eighty per cent of the workforce employed to

- 1 perform the contract on a particular construction, as determined
- 2 under subsection (b).
- 3 (b) The eighty per cent requirement under subsection (a)
- 4 shall be determined by dividing the total number of hours worked
- 5 on a contract by residents, by the total number of hours worked
- 6 by all employees of the contractor in the performance of the
- 7 contract. Hours worked for any subcontractor of the contractor
- 8 shall count towards the calculation for purposes of this
- 9 subsection. The hours worked by employees within shortage
- 10 trades, as determined by the department of labor and industrial
- 11 relations, shall not be included in the calculations for
- 12 purposes of this subsection.
- 13 (c) Every contractor shall comply with this chapter for
- 14 the entire duration of the contract. Certification of
- 15 compliance with this chapter shall be made under oath by an
- 16 officer of the contractor to the procurement officer on a
- 17 monthly basis.
- (d) A contractor who fails to comply with this chapter
- 19 shall be subject to any of the following sanctions:
- 20 (1) Temporary suspension of work on the project until the
- 21 contractor or subcontractor complies this chapter;

1	(2)	Withholding of payment on the contract or subcontract,
2		as applicable, until the contractor or subcontractor
3		complies with this chapter;
4	(3)	Permanent disqualification of the contractor or
5		subcontractor from any further work on the project;
6	(4)	Recovery by the State or county, as applicable, of any
7		moneys expended on the contract or subcontract, as
8		applicable; or
9	(5)	Proceedings for debarment or suspension of the
10		contractor or subcontractor under section 103D-702.
11	§	-D Conflict with federal law. This chapter shall not
12	apply if	the application of this chapter is in conflict with any
13	federal l	aw, or if the application of this chapter will
14	disqualif	y any state or county agency from receiving federal
15	funds or	aid."
16	SECT	ION 3. This Act does not affect rights and duties that
17	matured,	penalties that were incurred, and proceedings that were
18	begun bef	ore its effective date.
