## A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that sewer maintenance 2 working supervisors, wastewater collection system inspection 3 supervisors, wastewater collection system district supervisors, 4 and wastewater collection system field services supervisors are 5 currently not included under the definition of "sewer worker" by 6 the employees' retirement system, despite the fact that these 7 workers are exposed to hazards that are similar to the other 8 types of position classifications covered under that definition. 9 The purpose of this Act is to expand the definition of 10 "sewer worker" to include sewer maintenance working supervisors, 11 wastewater collection system inspection supervisors, wastewater
