Report Title: Long Term Care Commission; Long Term Care Fund

#### Description:

Requires the long term care commission to review the feasibility of establishing a long term care fund to assist residents who would otherwise not qualify for any government or private long term care insurance program. Finances the fund by imposing or increasing the general excise tax on food and drugs commencing 1/1/12. Requires conclusions and recommendations of the review to be included in the commission's final report to the legislature on 9/30/10.
