BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 103D-102, Hawaii Revised Statutes, is 2 amended by amending subsection (c) to read as follows: 3 Notwithstanding subsection (a), this chapter shall "(C) 4 not apply to contracts made by any regional system board of the 5 Hawaii health systems corporation [-,], or, except with respect to 6 part X, the University of Hawaii or the board of regents of the 7 University of Hawaii." 8 SECTION 2. Section 304A-105, Hawaii Revised Statutes, is 9 amended by amending subsection (b) to read as follows: 10 "(b) The board of regents shall develop internal policies 11 and procedures for the procurement of goods, services, and 12 construction, consistent with the goals of public accountability 13 and public procurement practices, which shall be subject to part 14 X of chapter 103D[-], section 103D-304, and chapter 104. Except 15 as provided in this subsection, chapter 103D shall not apply to 16 any actions or activities undertaken, conducted, or performed 17 under authority of the board of regents or the university; 18 provided that the board of regents is encouraged to use the HB347 HD2 HMS 2009-2726

1	provisions of chapter 103D as guidelines; provided further that
2	in using one or more provisions of chapter 103D as guidelines,
3	neither the board of regents nor the university shall be:

7	(2) Subject to any of the provisions or requirements of
