BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 103D-701, Hawaii Revised Statutes, is
 amended by amending subsection (f) to read as follows:

3 "(f) In the event of a timely protest under subsection (a), no further action shall be taken on the solicitation or the 4 award of the contract until the chief procurement officer makes 5 a written determination that the award of the contract without 6 delay is necessary to protect substantial interests of the 7 State [-]; provided that this subsection shall not apply to the 8 University of Hawaii or the board of regents of the University 9 10 of Hawaii."

SECTION 2. Section 103D-709, Hawaii Revised Statutes, is amended by amending subsection (e) to read as follows:

13 "(e) No action shall be taken on a solicitation or an
14 award of a contract while a proceeding is pending, if the
15 procurement was previously stayed under section 103D-701(f) [-];
16 provided that this subsection shall not apply to the University
17 of Hawaii or the board of regents of the University of Hawaii."
