BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 514B-144, Hawaii Revised Statutes, is

9	year. Any late fee for a past due common expense assessment
10	shall not exceed twenty per cent of the monthly maintenance fee
11	in effect at the time the delinquency occurs."
12	SECTION 2. Section 514B-157, Hawaii Revised Statutes, is
13	amended by amending subsection (a) to read as follows:
14	"(a) All costs and expenses, including reasonable

2	(3) Enforcing any provision of the declaration, bylaws,
3	house rules, and this chapter, or the rules of the

7	promptly paid on demand to the association by such person or
8	persons; provided that the association shall give the delinquent
9	unit owner written notice of any delinquency no fewer than ten
10	business days before taking any action for which attorneys' fees
11	may be assessed; provided further that if the claims upon which
12	the association takes any action are not substantiated, all
13	costs and expenses, including reasonable attorneys' fees,

Description:
