

### A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 6E-2, Hawaii Revised Statutes, is
- 2 amended by adding three new definitions to be appropriately
- 3 inserted and to read as follows:
- 4 ""Photographs" mean dated pictures, not taken more than one
- 5 month prior to applying for any building permit affecting the
- 6 exterior of the structure, in any clearly visible format,
- 7 including electronic formats.
- 8 "Photographs of the historic building" means, at the least,
- 9 pictures of the building exterior, including window treatments,
- 10 doors, roof line and interesting architectural details, such as
- 11 gables, finials, rock wall foundations or porches.
- "Eliqible for listing on the Hawaii or national register"
- 13 means that a property meets the criteria for listing on the
- 14 Hawaii register of historic places, as set forth in title 13,
- 15 chapter 198, Hawaii administrative rules, or meets the criteria
- 16 for listing on the National Register of Historic Places, as set
- 17 forth in Title 36, Code of Federal Regulations, Part 60, Section
- 18 60.4."

1	SECTION 2. Section 6E-8, Hawaii Revised Statutes, is		
2	amended by amending subsection (a) to read as follows:		
3	"(a) Before any agency or officer of the State or its		
4	political subdivisions commences any project which may affect		
5	historic property, aviation artifact, or a burial site, the		
6	agency or officer shall advise the department and allow the		
7	department an opportunity for review of the effect of the		
8	proposed project on historic properties, aviation artifacts, or		
9	burial sites, consistent with section 6E-43, especially those		
10	listed on the Hawaii register of historic places. The proposed		
11	project shall not be commenced, or in the event it has already		
12	begun, continued, until the department shall have given its		
13	written concurrence. In the case of any building that [is		
14	eligible for listing or is listed or is eligible for listing		
15	on the Hawaii or national register of historic places, no		
16	demolition, construction, or other alteration of the building		
17	shall occur until after the responsible agency, officer, or		
18	county has transmitted [archival quality black and white]		
19	photographs of the historic building to the department. $\underline{\mathtt{A}}$		
20	person meeting the professional qualifications of architect,		
21	architectural historian, ethnographer, historian, or physical		
22	anthropologist set forth in title 13, chapter 281, Hawaii

- 17 improvement of any nature, by, for, or permitted by a private
- 18 landowner may be commenced which will affect an historic
- 19 property on the Hawaii register of historic places, the
- 20 landowner shall notify the department of the construction,
- 21 alteration, disposition, or improvement of any nature and allow
- 22 the department opportunity for review of the effect of the

2	of any nature on the historic property. The proposed		
3	construction, alteration, disposition, or improvement of any		
4	nature shall not be commenced, or in the event it has already

6	given its	concurrence or ninety days have elapsed. Within	
7	ninety da	ys after notification, the department shall:	
8	(1)	Commence condemnation proceedings for the purchase of

- "[+] §46-3.5[+] Photographs of historic property.
- 12 Notwithstanding any other law to the contrary, each county
- 13 agency that issues building, construction, or development-
- 14 related permits shall not issue any permit allowing the
- 15 demolition, construction, or other alteration of [a] an historic
- 16 building until after a permit applicant provides proof of having
- 17 provided the department of land and natural resources with
- 18 [archival quality black and white] photographs of the historic
- 19 building, as required under chapter 6E."
- 20 SECTION 5. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.
- 22 SECTION 6. This Act shall take effect upon its approval.

#### Report Title:

Historic Preservation; Photographs

#### Description:

Narrows the requirement to submit photographs of historic buildings prior to construction permit approval to apply to buildings meeting established criteria of historical significance and deletes the requirement that photographs must be of archival quality.
