### A BILL FOR AN ACT

RELATING TO HISTORIC STRUCTURES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 6E-2, Hawaii Revised Statutes, is			
2	amended by adding a new definition to be appropriately inserted			
3	and to read as follows:			
4	" "Major alteration" means a modification of a structure			
5	that involves any of the following:			
6	(1) An alteration to more than fifty per cent of the			
7	original structure's square footage; or			
8	(2) A two story addition to a single story structure."			
9	SECTION 2. Section 6E-8, Hawaii Revised Statutes, is			
10	amended by amending subsection (a) to read as follows:			
11	"(a) Before any agency or officer of the State or its			
12	political subdivisions commences any project which may affect			
13	historic property, <u>an</u> aviation artifact, or a burial site, the			
14	agency or officer shall advise the department and allow the			
15	department an opportunity for review of the effect of the			
16	proposed project on historic properties, aviation artifacts, or			
17	burial sites, consistent with section 6E-43, especially those			



1 listed on the Hawaii register of historic places. The proposed 2 project shall not be commenced, or in the event it has already 3 begun, continued, until the department shall have given its 4 written concurrence. In the case of any building that is 5 eligible for listing or is listed on the Hawaii or national 6 register of historic places, no demolition [, construction, or 7 other alteration] or major alteration of the building shall 8 occur until after the responsible agency, officer, or county has 9 transmitted [archival quality black and white] photographs of 10 the historic building to the department.

11 The department is to provide written concurrence or non-12 concurrence within [ninety days] thirty days for commercial 13 structures, or fifteen days for single family dwellings, after 14 the filing of a request with the department. The agency or 15 officer seeking to proceed with the project, or any person, may 16 appeal the department's concurrence or non-concurrence to the 17 Hawaii historic places review board. [An agency, officer, or 18 other person who is dissatisfied with the decision of the review 19 board may apply to the governor, who may request the Hawaii 20 advisory council on historic preservation to report or who may 21 take action as the governor deems best in overruling or

22 sustaining the department.]"

17		registered on the Hawaii or national register; and
18	(3)	Recommending a self-sufficient funding mechanism that
19		will enable the state historic preservation division
20		to help preserve a broader range of culturally or
21		historically significant structures.
