A BILL FOR AN ACT

RELATING TO SHORELINE SETBACKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that beaches are unique 2 assets of the state created by a decades-long natural process of 3 erosion and accretion. For the past several decades, the beachfront of Kailua beach has increased to the benefit of beach 4 users from around the state and the nation. Kailua beach is 5 special within the state as one of the few beaches that is fully 6 7 urban, accreting, and entirely unarmored. This asset, however, 8 remains impacted by erosion related to sand deficiencies at 9 Kailua beach park, as well as the threat of future sea-level rise. Because the southern end of Kailua beach is now subject 10 11 to long-term erosion, which is migrating northward with time, the protection and conservation of Kailua beach by minimizing 12 13 current and future impacts of shoreline erosion is imperative. Proper management, achieved through appropriate shoreline 14 15 setbacks within which construction is prohibited, will:

16 (1) Help to protect development from coastal hazards;

17 (2) Conserve and protect the beach;

1 (4) Minimize future impacts to the coastal ecosystem. 2 With long-term sea-level rise and without necessary coastal 3 management planning, these issues will become more critical. 4 Accreted beach land, in the form of coastal dunes and dry 5 beach area, is still an integral portion of the beach system. Accreted land holds the fragile carbonate sands, which the 6 active beach relies upon during periods of episodic erosion. 7 8 These same lands will once again transition back into active 9 beach area as the shoreline migrates and sea-level rises. As 10 the shoreline migrates through accretion and erosion, so too 11 does the conservation district boundary, where all submerged 12 lands are zoned as resource sub-zone. The accreted lands, originally within the conservation district, will not only 13 14 return to the conservation district with subsequent erosion, but 15 also have a significant impact on the function and health of the 16 beach resource to be conserved and protected within the existing 17 conservation district boundaries. From a management 18 perspective, it is more effective for one agency to steward the 19 entire resource, or multiple agencies to follow a single 20 integrated management plan for the entire resource. As there 21 are currently no shoreline structures on Kailua beach, with the 22 exception of the boat ramp and ancillary structure at the south HB593 HD2 HMS 2009-2860
