A BILL FOR AN ACT

RELATING TO THE HAWAII EXPORT CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 201, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§201-</u> Hawaii export center; established; location;
5	purpose; rules. (a) There shall be established the Hawaii
6	export center within the department of business, economic
7	development, and tourism.
8	(b) The Hawaii export center shall be located on state
9	land within the Kalaeloa community development district pursuant
10	to section 206E-193.
11	(c) It shall be the purpose of the Hawaii export center to
12	facilitate and expedite the export of products of small export
13	businesses in the State by managing and coordinating the
14	efficient sharing of shipping containers for multiple small
15	export businesses. The Hawaii export center shall be the locus
16	of export shipping facilities targeted to serve small export
17	businesses in the State who do not have large enough quantities

1	of product to completely fill one standard shipping container
2	for export at any one time.
3	(d) The department of business, economic development, and
4	tourism shall contract with a private entity to manage the
5	operations of the Hawaii export center. The department shall
6	adopt rules in accordance with chapter 91 to establish a process
7	for a private entity to bid for and be awarded a contract to
8	manage the operations of the Hawaii export center and shall
9	include provisions for leases, maintenance, and fulfillment for
10	exporters."
11	SECTION 2. Chapter 206E, Hawaii Revised Statutes, is
12	amended by adding a new section to part VII to be appropriately
13	designated and to read as follows:
14	"§206E- Hawaii export center; jurisdiction.
15	Notwithstanding this part or any other law to the contrary, the
16	department of business, economic development, and tourism shall
17	have exclusive jurisdiction over the management and operation of
18	the Hawaii export center located within the Kalaeloa community
19	develop district pursuant to section 201"
20	SECTION 3. The department of business, economic
21	development, and tourism shall submit a written report to the
22	legislature no later than twenty days prior to the convening of
