# A BILL FOR AN ACT

RELATING TO MASS TRANSIT ROUTE ECONOMIC ZONES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1 (a) There is created the temporary mass transit 2 route economic zone task force within the department of 3 business, economic development, and tourism for administrative 4 purposes only. The task force shall be chaired by the director 5 of business, economic development, and tourism, who shall be a voting member. The task force shall also consist of the 6 7 following members or their designees: 8 (1)Director of transportation; Director of taxation; 9 (2) Director of finance; 10 (3)11 (4)Director of labor and industrial relations: Director of the department of planning and permitting 12 (5)13 of the city and county of Honolulu; 14 (6)Chairperson of the board of land and natural 15 resources; 16 (7)Executive director of the Hawaii community development 17 authority;

- President of the University of Hawaii; 3 (9)

- Two members appointed by the speaker of the house of 9 (13)10 representatives.
- The members shall serve without compensation but shall 11 (b) 12 be reimbursed for expenses, including travel expenses, necessary 13 for the performance of their duties.
- 14 The task force shall convene its first meeting no later than twenty days after the effective date of this Act. 15
- 16 The task force shall examine the concept and 17 feasibility of establishing economic zones proximate to the 18 route or routes of any future mass transit system on the island 19 of Oahu, particularly in the areas surrounding transit stops 20 that are economically depressed. The task force shall consider, 21 evaluate, and determine at least the following components and
- 22 structure of a mass transit route economic zone:

16		offered to qualified participants;
17	(5)	Whether there will be a focus on affordable housing,
18		medical services, or any other particular type of
19		participating business, entity, or organization in an
20		economic zone;

1	(6)	Consideration of the possibility of granting benefits
2		similar to those available in a state enterprise zone
3		pursuant to chapter 209E, Hawaii Revised Statutes;
4	(7)	The need for the exercise of the power of eminent
5		domain;
6	(8)	Potential jurisdictional conflicts between the State
7		and the city and county of Honolulu;
8	(9)	Estimates of the costs of implementing mass transit
9		route economic zones; and
10	(10)	Any other issue deemed relevant by the task force.
11	(e)	The task force shall submit a report of findings and
12	recommenda	ations, including any necessary proposed legislation,
13	to the leg	gislature no later than twenty days prior to the
14	convening	of the regular session of 2010. The task force report
15	shall incl	lude:
16	(1)	The process by which the department of business,
17		economic development, and tourism will designate a
18		particular area a mass transit route economic zone,
19		including the procedure by which the council of the
20		city and county of Honolulu and the mayor of the city
21		and county of Honolulu may apply for economic zone

Report to legislature, including process to designate economic zones and incentives to attract businesses and affordable housing to encourage ridership. Task force terminates on 06/30/10.
