### A BILL FOR AN ACT

RELATING TO HEALTH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The legislature finds that approximately ten
2	per cent	of the adult population of the State of Hawaii has no
3	public or	private health insurance. In the current economic
4	climate o	f the State, this number is likely to increase as the
5	result of	work layoffs and business closures. According to the
6	Kaiser Co	mmission on Medicaid and the Uninsured:
7	(1)	Over four out of five uninsured people are in working
8		families;
9	(2)	Uninsured people are more likely than those with
10		insurance to be hospitalized for conditions that could
11		have been avoided;
12	(3)	Because the uninsured are less likely to seek regular
13		and preventive care, those with various forms of
14		cancer or with chronic conditions are more likely to
15		be diagnosed in later stages of their diseases
16		resulting in higher rates of death and disability; and



(4) Nearly forty per cent of uninsured adults skipped a
 recommended medical test or treatment, and twenty per
 cent say they needed but did not get care for a
 serious problem in the past year.

5 The significant numbers of uninsured residents have a
6 considerable economic impact on the State's hospitals, community
7 health centers, and other health care providers, threatening
8 their ability to effectively serve the whole community.

9 The legislature finds that it is in the best interests of 10 the State to ensure access to primary and preventive health care 11 for its residents. In addition to facilitating a healthier 12 population, improving access to health care reduces state 13 expenditures attributable to hospital and emergency room 14 services for preventable injuries or illnesses.

15 The legislature further finds that the most effective means 16 to encourage access to primary health care for residents without 17 health insurance is through Hawaii's system of federally 18 gualified health centers. These centers:

19 (1) Are nonprofit, community-based organizations whose
 20 purpose and expertise lie in serving people who
 21 otherwise have limited or no access to health care;



(2) Provide culturally and linguistically appropriate
 health care and a broad range of primary care and
 preventive services, and are located in medically underserved areas where people have limited access to
 other health care providers because of geographic and
 socio-economic barriers;

7 (3) Contribute greatly to the economies and livability of8 the communities they serve; and

9 (4) Are cost-effective providers whose care results in
10 healthier patients and decreased use of emergency,
11 specialty, and in-patient services. A recent study
12 shows that community health centers saved Hawaii an
13 estimated \$29,000,000 in 2007 in their services to the
14 uninsured.

Unfortunately, while federally qualified health centers represent one of the most effective and responsive systems of community-based primary care for uninsured people, financial support for these providers is inadequate to meet needs for medical, behavioral health, and dental services.

20 The purpose of this Act is to provide cost-effective health 21 care for Hawaii residents who are uninsured while at the same 22 time ensuring that the community health center system remains



1 financially viable and stable in the face of a growing 2 population of uninsured persons. 3 There is appropriated out of the general SECTION 2. 4 revenues of the State of Hawaii the sum of \$ or so 5 much thereof as may be necessary for fiscal year 2009-2010 to 6 pay for the provision of direct health care for the uninsured, 7 which may include primary medical, dental, and behavioral health care; provided that distribution of funds may be on a "per 8 9 visit" basis, taking into consideration need on all islands. 10 The sum appropriated shall be expended by the department of health to provide resources to nonprofit, community based health 11 12 care providers for the provision of health care for uninsured 13 persons. SECTION 3. This Act shall take effect on July 1, 2009. 14 15
