## A BILL FOR AN ACT

RELATING TO CIVIL PROCEDURE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 657, Hawaii Revised Statutes, is
2	amended by adding a new section to part I to be appropriately
3	designated and to read as follows:
4	" <u>§657-</u> Limitation of actions; coercion into
5	prostitution; drug dealer liability; sexual offenses against
6	minors. (a) Notwithstanding any statutory provision to the
7	contrary, a claim based on any of the following causes shall be
8	brought within forty years of the commission of the tort giving
9	rise to the claim:
10	(1) Liability for coercion into prostitution, under
11	chapter 663J;
12	(2) Drug dealer liability, under chapter 663E; or
13	(3) Commission of a sexual offense, as defined in section
14	846E-1, against a minor.
15	(b) Vicarious liability and respondeat superior may be
16	alleged and shall be presumed if an employee or agent of an
17	entity is found to be liable in a claim brought under this
18	section.

4	SECTION 2. Section 663E-9, Hawaii Revised Statutes, is
5	amended by amending subsection (a) to read as follows:

8	clear and convincing evidence. Except as otherwise provided in
9	this chapter, other], all elements of the cause of action,
10	including proof of participation in the illegal drug market,
11	shall be shown by a preponderance of the evidence."
12	SECTION 3. Section 663E-4, Hawaii Revised Statutes, is
13	repealed.
14	[" <b>[§663E-4] Third party cases.</b> Notwithstanding any other
15	law to the contrary, no person shall be liable under this
16	chapter under civil principles of vicarious liability."]
17	SECTION 4. This Act does not affect rights and duties that
18	matured, penalties that were incurred, and proceedings that were
19	begun, before its effective date.
