4	A person commits the offense of cruelty to animals by fighting

8	shall be engaged in an exhibition of fighting with
9	another dog;
10	(b) For amusement or gain, intentionally causes any dog to
11	fight with another dog, or causes any dog to injure
12	another dog; or
13	(c) Knowingly or recklessly permits any act in violation
14	of paragraph (a) or (b) to be done on the premises
15	under the person's charge or control, or aids or abets
16	any such act.]
17	(a) Causes, sponsors, arranges, or holds a dogfight;

1	(b)	Owns, trains, transports, possesses, breeds, sells,
2		transfers, or equips any dog with the intent that such
3		dog shall be engaged in a dogfight;
4	(c)	Allows a dogfight to occur on any property owned or
5		controlled by the person;
6	(d)	Allows any dog intended by the person to be used for a
7		dogfight to be kept, boarded, housed, trained on, or
8		transported in, any property owned or controlled by
9		the person;
10	(e)	Wagers or pays admission on a dogfight; or
11	(f)	Possesses any device intended to enhance the dog's
12		fighting ability with the intent that the device be
13		used to train or prepare the dog for a dogfight.
