BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

9	(1)	Designed for operation off of the highway by an
10		operator with no more than one passenger;
11	(2)	Fifty inches or less in width;
12	(3)	Nine hundred pounds or less unladen weight;
13	(4)	Suspended on three or more tires;
14	(5)	Has a single seat designed to be straddled by the
15		operator, or a single seat designed to be straddled by
16		the operator and a seat for not more than one
17		passenger; and

1	(6) Has handlebars for steering control.		
2	"Minor" means a person under the age of eighteen.		
3	§286-B Prohibition; minors; operation. (a) No minor		
4	shall operate, ride, or be otherwise propelled on an all-terrain		
5	vehicle.		
6	§286-C Penalty. A violation of this section is		
7	punishable by a fine of not more than \$50. The parent or legal		
8	guardian having control or custody of an unemancipated minor		
9	whose conduct violates this section shall be liable for the		
10	amount of the fine imposed pursuant to this section.		
11	Notwithstanding any law to the contrary, the fines collected for		
12	a violation of this section shall be paid into the state		
13	treasury to the credit of the state general fund."		
14	SECTION 2. In codifying the new sections added by section		
15	1 of this Act, the revisor of statutes shall substitute		
16	appropriate section numbers for the letters used in designating		
17	the new sections in this Act.		
18	SECTION 3. New statutory material is underscored.		
19	SECTION 4. This Act shall take effect upon its approval.
