A BILL FOR AN ACT

RELATING TO PUBLIC WORKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 104, Hawaii Revised Statutes, is 2 amended by adding a new part to read as follows: "PART . PUBLIC WORKS; OTHER REQUIREMENTS 3 4 **§104-A Definitions.** For the purposes of this part, unless 5 the context otherwise requires: 6 "Contract" has the same meaning as in section 104-2. 7 "New work on any public work" means any work at the job 8 site that is under contract by the suspended party of contractor 9 that has not commenced before the date of the suspension order. 10 "Public work" has the same meaning as in section 104-2. 11 **§104-B Status of employees.** All parties as defined in 12 section 104-2 and contractors who bid on a public work shall 13 employ only regular employees, as defined in section 393-3, who 14 shall not be classified as independent contractors. 15 **\$104-C** Apprenticeship program. (a) All parties and 16 contractors who bid on a public work shall maintain an

17 apprenticeship program certified by the State.



(b) The director shall adopt rules under chapter 91 to
 implement this section.

§104-D Apprentice use on public works; requirements. (a)
All public works projects that cost one million dollars or more
shall include a requirement that no less than fifteen per cent
of labor hours on the project be performed by individuals
enrolled in an apprenticeship program established under section
104-C.

9 For the purposes of this subsection, "labor hours" means 10 the total number of hours worked by employees receiving an 11 hourly wage who are directly employed on the site of a public 12 works project, including hours performed by individuals employed 13 by the contractor and all subcontractors working on the project. 14 "Labor hours" does not include hours worked by foremen, 15 superintendents, owners, clerical staff, and other workers not 16 subject to prevailing wage requirements.

17 (b) The director shall adopt rules under chapter 91 to18 implement this section.

19 \$104-E Violations; penalties. (a) Where the department 20 finds that a violation of this part has been committed, the 21 department, after proper notice and opportunity for hearing,



1 shall order the governmental contracting agency, as defined in 2 section 104-2, to: 3 Suspend all work being conducted by the party or (1)4 contractor on the public work where the violation has 5 occurred; Withhold any further payments to the party or 6 (2)contractor found to have committed the violation; and 7 (3) Assess a weekly penalty equivalent to one-tenth of one 8 9 per cent of the contract, or \$1,000, whichever is 10 greater, until compliance with section 104-B, 104-C, or both is obtained. 11 12 Where the department finds that compliance with this (b) 13 part is not obtained within days after notification, the 14 department shall order the governmental contracting agency to 15 permanently remove the party or contractor from any further work on the public work. The department, after proper notice and 16 17 opportunity for hearing, shall order the party or contractor in 18 violation to be suspended from performing any new work on any 19 public work of a governmental contracting agency for a period of 20 six months.

(c) Where the department finds that a second violation ofthis part has been committed, whether on the same contract or



another, within two years of the first notification of 1 2 violation, the department, after proper notice and opportunity 3 for hearing, shall order the party or contractor in violation to be suspended from performing any new work on any public work of 4 a governmental contracting agency for a period of three years. 5 6 Where the department finds that a third violation of (d) 7 this part has been committed, whether on the same contract or another, within two years of the second notification of 8 9 violation, the department, after proper notice and opportunity 10 for hearing, shall order the party or contractor in violation to be suspended permanently from performing any new work on any 11 12 public work of a governmental contracting agency. 13 SECTION 2. Chapter 104, Hawaii Revised Statutes, is 14 amended as follows: 15 1. By amending its title to read: "CHAPTER 104 16 [WAGES AND HOURS OF EMPLOYEES ON] PUBLIC WORKS" 17 18 2.
