## HOUSE CONCURRENT RESOLUTION

URGING THE UNITED STATES GOVERNMENT TO SEEK REIMBURSEMENT FROM THE FEDERATED STATES OF MICRONESIA FOR SERVICES PROVIDED IN HAWAII TO MIGRANTS UNDER THE COMPACT OF FREE ASSOCIATION.

1 WHEREAS, in 1986, the United States (U.S.) entered into a 2 Compact of Free Association (COFA or Compact) with the Federated 3 States of Micronesia and the Republic of the Marshall Islands 4 that created a unique relationship between the U.S. and the COFA 5 states; and

7 WHEREAS, the terms of the Compact set out mutually 8 beneficial rights and obligations in several areas, including 9 economic development and defense, and created the right of 10 citizens from the COFA states to freely travel to, and work and 11 reside in, the U.S. without durational limit; and

WHEREAS, a significant number of COFA citizens travel to
and reside in the State of Hawaii because of the geographic
location and cultural similarity; and

WHEREAS, many COFA migrants find it difficult to adjust to
Hawaii's high cost of living and as a result, require state
assistance; and

WHEREAS, in the amended Compact of 2003, Congress recognized there could be a significant effect on the resources of the places to which COFA citizens migrated and explicitly stated that, "it is not the intent of Congress to cause any adverse consequences for an affected jurisdiction"\_P.L. 108-188, section 104(e)(1)(emphasis added); and

WHEREAS, in support of the intent to ease the burden on
areas defined as an "affected jurisdiction," including Hawaii,
Congress set aside \$30,000,000 in grant funds; however, those

1 funds are not nearly enough to cover the additional costs to all affected jurisdictions; and 2 3 4 WHEREAS, in 1997, Congress passed the Personal 5 Responsibility Work Opportunities Reconciliation Act (PRWORA), which provided that most non-citizens in the U.S., with limited 6 exceptions, became ineligible for federally-funded welfare 7 programs including Temporary Assistance for Needy Families, 8 9 Medicaid, Food Stamps, and Supplemental Security Income, thereby exacerbating an already tenuous fiscal situation for the states; 10 11 and 12 WHEREAS, COFA migrants were among the non-citizen groups 13 that became ineligible for federally-funded public assistance 14 15 programs under PRWORA despite the fact that they are legal residents in the U.S., and are more like citizens than 16 immigrants or other legally-residing non-citizens in terms of 17 their ability to reside, work, and attend school in the U.S.; 18 19 and 20 WHEREAS, despite losing access to federal funds for 21 22 services to COFA migrants because of PRWORA, the State of Hawaii 23 has continued to make the services available through equivalent state-funded services to address the needs of COFA citizens who 24 25 legally reside in the state, just as it provides them to other legal residents; and 26 27 28 WHEREAS, the State has consistently reported increasing costs each year for the services provided to COFA migrants, the 29 majority of which are not reimbursed by the federal government; 30 and 31 32 WHEREAS, the federal government created the relationship 33 with the COFA states that allows their citizens to freely reside 34 in the U.S. with few limitations; now, therefore, 35 36 37 BE IT RESOLVED by the House of Representatives of the 38 Twenty-fifth Legislature of the State of Hawaii, Regular Session of 2010, the Senate concurring, that the Legislature hereby 39 urges the U.S. Government to seek reimbursement from the 40 Federated States of Micronesia for services provided in Hawaii 41 42 to migrants under COFA; and
