HOUSE RESOLUTION

URGING THE HAWAII HOUSING FINANCE AND DEVELOPMENT CORPORATION TO ADOPT POLICIES THAT PROVIDE FULL DISCLOSURE OF TAX EXEMPTIONS IT CERTIFIES.

WHEREAS, the global financial crisis that began in the 1 second half of 2008 has put increasing pressure on states across 2 3 the country to resolve complex budget deficits; and 4 WHEREAS, in Hawaii, the state budget deficit has grown to 5 \$1,200,000,000, despite numerous creative efforts to raise 6 revenue and reduce costs; and 7 8 WHEREAS, over several decades, more than 50 classes of 9 transactions have been granted an exemption from the state 10 general excise tax, often to provide incentives for desired 11 social and economic behavior or to conform Hawaii tax codes to 12 federal law; and 13 14 WHEREAS, each year, the state forgoes approximately 15 \$835,000,000 in potential revenue by exempting various companies 16 and individuals from the general excise tax; and 17 18 WHEREAS, although a temporary suspension of general excise 19 tax exemptions may help address the State's budget shortfall, 20 certain tax incentives remain necessary; and 21 22 WHEREAS, the construction of affordable housing continues 23 to require the full effort of the Hawaii construction industry 24 while construction itself can act as a spur for economic 25 activity, thereby making the continuance of a tax incentive for 26 these activities appropriate; and 27 28 WHEREAS, the State maintains the responsibility, however, 29 to ensure the proper use and reporting of affordable housing tax 30 credits; and 31 32 33 WHEREAS, the Hawaii Housing Finance and Development 34 Corporation (HHFDC) is the primary agency involved in approving
