A BILL FOR AN ACT

RELATING TO DETENTION AND RETENTION PONDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act shall be known as the "Charlotte
- 2 'Sharkey' Schaefers Act", in memory of the young girl who
- 3 drowned in 2004 while attempting to rescue a friend who had
- 4 fallen into a retention pond.
- 5 SECTION 2. The legislature finds that unregulated and
- 6 poorly maintained rainwater detention and retention ponds can
- 7 potentially pose a health and safety risk, particularly to
- 8 Hawaii's children. Since rainwater retention and detention
- 9 ponds can sometimes be mistaken for recreational bodies of
- 10 water, safety features may be prudent to protect children from
- 11 drowning.
- 12 The purpose of this Act is to establish a task force to
- 13 investigate and examine the dangers of retention ponds and to
- 14 recommend appropriate safety measures.
- 15 SECTION 3. (a) There is established in the department of
- 16 health a temporary water safety task force to be composed of the
- 17 following officials or their designee:
