A BILL FOR AN ACT

RELATING TO PUBLIC DEFENDER SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended 2 by adding a new section to be appropriately designated and to
- 2 by adding a new beceroif to be appropriately debignated and
- 3 read as follows:
- 4 "§46- Public defender services. In addition to section
- 5 46-1.5, each county shall provide public defender services under
- 6 chapter 802."
- 7 SECTION 2. Chapter 802, Hawaii Revised Statutes, is
- 8 amended by adding a new section to be appropriately designated
- 9 and to read as follows:
- 10 "§802- Public defender services; counties. (a)
- 11 Beginning July 1, 2010, each county shall provide public
- 12 defender services for indigents, as provided in this chapter.
- (b) Each county shall appoint and set the compensation of
- 14 the county public defender who shall be responsible for the
- duties as provided in this chapter within the respective
- 16 county's jurisdiction. The qualifications of the county public
- 17 defender shall be set by the county; provided that the county

         ["$802-11 Appointment of state public defender. The state

    defender's appointment shall be for a term of four years except

    as otherwise provided herein, and until the state public

    defender's successor is appointed and qualified. The state

    public defender shall be qualified to practice law before the
    supreme court of this State. Effective July 1, 2005, the state

    public defender shall be paid a salary set at eighty seven per

1 including investigators, as may be necessary to discharge the 2 function of the office. Assistant state public defenders shall 3 be qualified to practice before the supreme court of this State. 4 Assistant state public defenders shall be appointed without 5 regard to chapter 76 and shall serve at the pleasure of the 6 state public defender. All other employees may be appointed in 7 accordance with chapter 76. An assistant state public defender 8 may be employed on a part time basis, and when so employed, the 9 assistant public defender may engage in the general practice of 10 law, other than in the practice of criminal law."] 11 SECTION 7. All rights, powers, functions, and duties of 12 the office of the state public defender are transferred to the 13 the city and county of Honolulu, county of Kauai, county of 14 Maui, and county of Hawaii, respectively. 15 All officers and employees whose functions are transferred 16 by this Act shall be transferred with their functions and shall 17 continue to perform their regular duties upon their transfer, 18 subject to the state personnel laws and this Act. 19 No officer or employee of the State having tenure shall 20 suffer any loss of salary, seniority, prior service credit, 21 vacation, sick leave, or other employee benefit or privilege as 22 a consequence of this Act, and such officer or employee may be



transferred or appointed to a civil service position without the 1 2 necessity of examination; provided that the officer or employee 3 possesses the minimum qualifications for the position to which 4 transferred or appointed; and provided that subsequent changes 5 in status may be made pursuant to applicable civil service and 6 compensation laws. 7 An officer or employee of the State who does not have 8 tenure and who may be transferred or appointed to a civil 9 service position as a consequence of this Act shall become a 10 civil service employee without the loss of salary, seniority, 11 prior service credit, vacation, sick leave, or other employee 12 benefits or privileges and without the necessity of examination; 13 provided that such officer or employee possesses the minimum 14 qualifications for the position to which transferred or 15 appointed. If an office or position held by an officer or employee 16 17 having tenure is abolished, the officer or employee shall not 18 thereby be separated from public employment, but shall remain in 19 the employment of the State or county with the same pay and 20 classification and shall be transferred to some other office or 21 position for which the officer or employee is eligible under the

- 1 personnel laws of the State as determined by the respective
- 2 mayor of the county.
- 3 SECTION 8. All appropriations, records, equipment,
- 4 machines, files, supplies, contracts, books, papers, documents,
- 5 maps, and other personal property heretofore made, used,
- 6 acquired, or held by the office of the state public defender
- 7 relating to the functions transferred to the city and county of
- 8 Honolulu, county of Kauai, county of Maui, and county of Hawaii,
- 9 respectively shall be transferred with the functions to which
- 10 they relate.
- 11 SECTION 9. It is the intent of this Act that the
- 12 transition of public defender services from the State to the
- 13 counties occur with minimal or no disruption of public defender
- 14 services. This Act addresses jurisdictional responsibilities
- 15 only for public defender services. This Act shall not be
- 16 interpreted as affecting professional legal services of public
- 17 defender services.
- 18 SECTION 10. Pursuant to article VIII, section 5, of the
- 19 Hawaii state constitution, there is appropriated out of the
- 20 general revenues of the State of Hawaii the sum of \$
- 21 or so much thereof as may be necessary for fiscal year 2009-2010

1	for transfer of public defender services from the State to each
2	county, as follows:

7	The sum appropriated shall be expended by the department of
8	budget and finance for the purposes of this Act.
