BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide incentives for the production of affordable housing by 2 authorizing the transfer of development rights and credits by 3 4 the office of planning, and directing the office of planning to 5 convene a working group to develop a plan and recommendations to 6 enhance and encourage the development of affordable housing, as defined in section 201H-57, Hawaii Revised Statutes, through the 7 8 transfer of development rights and credits to transit-oriented 9 development districts, and to report to the 2010 legislature. 10 SECTION 2. Chapter 225M, Hawaii Revised Statutes, is 11 amended by adding a new section to be appropriately designated 12 and to read as follows: 13 Transfer of development rights and credits. "§225M− The
