## A BILL FOR AN ACT

RELATING TO HEALTHCARE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that two medical homes
2	located on Oahu, Waianae Coast Comprehensive Health Center and
3	the Waimanalo Health Center, provide cultural, community-based
4	services, including integrated behavioral services, which are
5	vital to the populations they serve. These medical homes are
6	uniquely situated to provide services to the patient populations
7	in their geographic area based on their integration with and
8	dedication to their respective communities. The Waianae Coast
9	Comprehensive Health Center and the Waimanalo Health Center
10	benefit not only their patients, but the communities in which
11	they are situated, as well. For example, the Waianae Coast
12	Comprehensive Health Center is the largest employer on the
13	Waianae Coast, and serves as an economic engine in this
14	low-income area.
15	Additionally, the legislature finds that a federal
16	demonstration project that provides for an alternative service
17	plan will save the State money, expand the geographic
