A BILL FOR AN ACT

RELATING TO THE ALOHA TOWER DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 206J, Hawaii Revised Statutes, is 2 repealed. 3 SECTION 2. All rights, powers, functions, and duties of 4 the aloha tower development corporation are transferred to the 5 department of business, economic development, and tourism. 6 All officers and employees whose functions are transferred 7 by this Act shall be transferred with their functions and shall 8 continue to perform their regular duties upon their transfer, 9 subject to the state personnel laws and this Act. 10 No officer or employee of the State having tenure shall 11 suffer any loss of salary, seniority, prior service credit, **12** vacation, sick leave, or other employee benefit or privilege as 13 a consequence of this Act, and such officer or employee may be 14 transferred or appointed to a civil service position without the 15 necessity of examination; provided that the officer or employee 16 possesses the minimum qualifications for the position to which **17** transferred or appointed; and provided that subsequent changes
