# A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION REGARDING THE CONVENING OF REGULAR LEGISLATIVE SESSIONS IN A PRESIDENTIAL INAUGURATION YEAR.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to propose an
2	amendment to article III, section 10, of the Constitution of the
3	State of Hawaii to ensure that the annual convening of the
4	legislature does not conflict with the inauguration of the
5	President of the United States.
6	SECTION 2. Article III, section 10, of the Constitution of
7	the State of Hawaii is amended to read as follows:
8	"SESSIONS
9	Section 10. The legislature shall convene annually in
10	regular session at 10:00 o'clock a.m. on the third Wednesday in
11	January $[\cdot]$ ; provided that, in any year in which the inauguration
12	of the President of the United States falls on any day of the
13	week that includes the third Wednesday in January, the
14	legislature shall convene in regular session at 10:00 o'clock
15	a.m. on the fourth Wednesday in January.

16	At the written request of two-thirds of the members to

houses shall convene the legislature in special session. At the written request of two-thirds of the members of the senate, the president of the senate shall convene the senate in special session for the purpose of carrying out its responsibility setablished by Section 3 of Article VI. The governor may convene both houses or the senate alone in special session.

7 Regular sessions shall be limited to a period of sixty
8 days, and special sessions shall be limited to a period of
9 thirty days. Any session may be extended a total of not more
10 than fifteen days. Such extension shall be granted by the
11 presiding officers of both houses at the written request of two12 thirds of the members to which each house is entitled or may be
13 granted by the governor.

14 Each regular session shall be recessed for not less than 15 five days at some period between the twentieth and fortieth days 16 of the regular session. The legislature shall determine the 17 dates of the mandatory recess by concurrent resolution. Any 18 session may be recessed by concurrent resolution adopted by a 19 majority of the members to which each house is entitled. 20 Saturdays, Sundays, holidays, the days in mandatory recess and 21 any days in recess pursuant to a concurrent resolution shall be 22 excluded in computing the number of days of any session.

1 All sessions shall be held in the capital of the State. In 2 case the capital shall be unsafe, the governor may direct that 3 any session be held at some other place." 4 SECTION 3. The question to be printed on the ballot shall 5 be as follows: 6 "Shall the constitution be amended to change the day on 7 which the legislature annually convenes from the third 8 Wednesday in January to the fourth Wednesday in January, 9 when the inauguration of the United States president falls 10 on any day of the week that includes the third Wednesday in 11 January?" 12 SECTION 4. Constitutional material to be repealed is 13 bracketed and stricken. New constitutional material is 14 underscored. 15 SECTION 5. This amendment shall take effect upon 16 compliance with article XVII, section 3, of the Constitution of 17 the State of Hawaii. 18
