RELATING TO TEACHER LICENSURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 164, Session Laws of Hawaii 2008, is
- 2 amended by amending section 1 to read as follows:
- 3 "SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
- 4 amended by adding a new section to subpart D of part III to be
- 5 appropriately designated and to read as follows:
- 6 "\$302A- Conviction of a teacher for sexual offense;
- 7 suspension of license; procedure for license revocation. (a)
- 8 The board may suspend an individual's license to teach without a
- 9 hearing upon receipt of a certified copy of a judgment of
- 10 conviction indicating that a teacher has been convicted of a
- 11 sexual offense as defined in section 846E-1, or under a similar
- 12 law of another state of the United States, and verification of
- 13 the identity of the teacher. Immediately upon suspension, the
- 14 board shall initiate proceedings in accordance with chapter 91
- 15 to permanently revoke an individual's license to teach.
- 16 (b) The clerk of the court in this state in which the
- 17 conviction of a teacher for any sexual offense against a minor,

- 1 suspension of the license pending the outcome of the 2 administrative hearing process established by chapter 91. 3 [(f)] (e) A person whose license to teach has been suspended pursuant to subsection (a) may petition the board to 4 5 reconsider the suspension and pending revocation pursuant to 6 chapter 91. Grounds for reconsideration shall include reversal 7 of the conviction by a final decision of the appellate court or 8 supreme court as well as the criteria specified in subsection 9 $[\frac{h}{h}]$ (g). The petitioner shall attach to the petition a 10 certified copy of the appellate court's final decision and any 11 other information supporting the petition. Upon receipt of the 12 petition, the board shall conduct a hearing on the matter 13 pursuant to chapter 91, unless waived by the petitioner, and may 14 reverse or affirm its previous decision to suspend and revoke, 15 notwithstanding the reversal of conviction or any other criteria

- 4 being of children within the school system. For convictions
- 5 under a similar law of another state of the United States, the
- $\mathbf{6}$ board shall determine that the conduct that is the basis for the
- 7 conviction would be sufficient to sustain a conviction for a
- 8 sexual offense as defined in section 846E-1 if the conduct had
- 9 occurred within the State of Hawaii."

- 11 and stricken. New statutory material is underscored.
- 12 SECTION 3. This Act shall take effect upon its approval.
