A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE HAWAII COUNTY ECONOMIC OPPORTUNITY COUNCIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the Hawaii County 2 Economic Opportunity Council is a private non-profit 3 organization established in 1965 whose sole purpose is to serve 4 the low-income population in the county of Hawaii. 5 Specifically, the agency has provided county-wide transportation 6 services for disadvantaged persons for more than thirty-three 7 years and is also the only agency in the county that provides 8 transportation exclusively for low-income persons. 9 The legislature further finds that the agency needs to 10 replace ten transportation vehicles in order to continue to 11 transport the county's low-income population to and from public 12 and private service facilities. 13 Accordingly, the legislature finds that appropriating funds to the Hawaii County Economic Opportunity Council for the 14 15 purchase of buses to serve the disadvantaged elderly, pre-school 16 children, and disabled persons throughout the county is an 17 appropriation for a public purpose. The purpose of this Act is provide funding for ten busses

 Pub.L. 111-5, can be used in lieu of the appropriation in this
 Act.

7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so 9 much thereof as may be necessary for fiscal year 2009-2010 for a 10 grant-in-aid to the Hawaii County Economic Opportunity Council 11 to purchase ten new buses to serve the disadvantaged elderly, 12 pre-school children, and disabled persons in Hawaii County; 13 provided that the appropriation shall not be expended if federal 14 funding under the American Recovery and Reinvestment Act of 15 2009, Pub. L. 111-5, can be used in lieu of the appropriation in 16 this Act.

17 The sum appropriated shall be expended by the Hawaii County
18 Economic Opportunity Council for the purposes of this Act.
19 SECTION 3. This Act shall take effect on July 1, 2099.
