BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:
4	"CHAPTER
5	CERTIFIED CASE MANAGERS
6	§ -1 Definitions. As used in this chapter, unless the
7	context clearly requires otherwise:
8	"Case management" means a holistic, comprehensive,
9	multidisciplinary approach to the assessment, planning,
10	coordination, implementation, monitoring, and evaluation of
11	comprehensive services to optimally meet an individual client's
12	health and social needs.
13	"Case manager" means a health care professional who:
14	(1) Is responsible for coordinating the health and social
15	care delivered to an assigned individual or group of
16	clients based on diagnosis or need;

1	(2)	Conducts client and family education, advocacy,
2		management of delays in provision of services, and
3		monitoring and management of client outcomes; and
4	(3)	Coordinates and cooperates with all relevant entitie
5		to obtain needed health and social care for the best

7	"Cert	cified case manager" means a case manager who has
8	obtained o	certification required by this chapter.
9	"Depa	artment" means the department of commerce and consume
10	affairs.	
11	"Dire	ector" means the director of commerce and consumer
12	affairs.	
13	§ -	-2 Certification required. Except as otherwise
14	provided :	in this chapter, no case manager shall:
15	(1)	Represent oneself as a certified case manager;
16	(2)	Imply, in any manner, that the case manager is a
17		certified case manager; or
18	(3)	Use the abbreviation "C.C.M." or any other words,
19		letters, signs, or devices to identify the case
20		manager as a certified case manager;

2	certification by department. To practice as a certified case
3	manager in the State, the department shall require a case
4	manager to pass the national certification examination
5	administered by the Commission for Case Manager Certification
6	required for certification by the Commission. Upon receipt of
.7	documentation from the case manager of certification by the
8	Commission to the satisfaction of the director, the department
9	shall certify the case manager as a certified case manager.
10	§ -4 Rules. The department shall adopt rules in
11	accordance with chapter 91 to carry out the effect of this
12	chapter."
