### A BILL FOR AN ACT

RELATING TO FIREWORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the expanded use of
- 2 illegal fireworks has escalated to a serious public health and
- 3 safety problem. The air pollution produced by consumer
- 4 fireworks causes respiratory difficulties for the elderly, young
- 5 children, and persons with existing respiratory ailments.
- 6 Fireworks set off in our neighborhoods create hazardous driving
- 7 conditions, cause needless stress for young children and pets,
- 8 and overextend our police and fire personnel as they respond to
- 9 incidents of fire and injury caused by fireworks as well as
- 10 numerous complaints about the illegal fireworks. Illegal
- 11 fireworks are much louder than consumer fireworks and cause
- 12 noise pollution and needless stress among the fragile groups
- 13 mentioned earlier. An immediate reduction in illegal fireworks
- 14 use is necessary to protect the health and safety of people in
- 15 this State.
- 16 The purpose of this Act is to increase the permit fees for
- 17 the purchase and use of fireworks and increase the penalty for

2	permit fees and fines collected may be used by county law	
3	enforcement personnel for purposes relating to fireworks.	
4	SECTION 2. Section 132D-10, Hawaii Revised Statutes, is	
5	amended to read as follows:	
6	"§13	2D-10 Permits. A permit shall be required for the
7	purchase	and use of:
8	(1)	Any consumer fireworks commonly known as firecrackers
9		upon payment of a fee of [\$25;] \$50. These fees may
10		be expended by the county for law enforcement purposes
11		relating to this chapter;
12	(2)	Any aerial devices, display fireworks, or articles
13		pyrotechnic for the purposes of section 132D-16 upon
14		payment of a fee of \$110; and
15	(3)	Any consumer fireworks for the purposes of section
16		132D-5 or for cultural uses that occur at any time
17		other than during the periods prescribed in section
18		132D-3(1) upon a payment of a fee of [\$25.] \$35.
19		These fees may be expended by the county for law
20		enforcement purposes relating to this chapter."
21	SECT	ION 3. Section 132D-11, Hawaii Revised Statutes, is

amended by amending subsection (a) to read as follows:

    shall be $3,000 for importers, $2,000 for each wholesaler's

- 1 "(b) Except as provided in subsection (a) or as otherwise
- 2 specifically provided for in this chapter, any person violating
- 3 any other provision of this chapter, shall be fined not more
- 4 than [\$2,000] \$4,000 for each violation.
- 5 (c) The court shall collect the fines imposed in
- 6 subsections (a) and (b) for violating this chapter and of the
- 7 fines collected shall pay twenty per cent to the State and
- 8 eighty per cent to the county in which the fine was imposed
- 9 which shall be expended by the county for law enforcement
- 10 purposes [-] relating to this chapter."
- 11 SECTION 5. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 6. This Act shall take effect upon approval.
