BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 103-55.6, Hawaii Revised Statutes, is 2 amended as follows:
- 3 1. By amending its title and subsection (a) to read:
- 4 "[+] §103-55.6[+] Public works construction; apprenticeship
- 5 agreement. (a) A governmental body, as defined in section
- 6 103D-104, that enters into a public works contract under this
- 7 chapter having an estimated value of not less than \$250,000,
- 8 shall decrease the bid amount of a bidder by five per cent if
- 9 the bidder, or a subcontractor employed by the bidder, is a
- 10 party to an apprenticeship agreement registered with the
- 11 department of labor and industrial relations for each
- 12 apprenticeable trade the bidder or subcontractor will employ to
- 13 construct the public works, and in conformance with chapter 372.
- 14 The lowest total bid, taking the preference into consideration,
- 15 shall be awarded the contract unless the solicitation provides
- 16 for additional award criteria. The contract amount awarded,

- 1 however, shall be the amount of the price offered, exclusive of
- 2 the preference."
- 3 2. By amending subsections (c) and (d) to read:
- 4 "(c) At the time of submission of a competitive sealed bid
- 5 or a competitive sealed proposal by a bidder, the bidder shall
- 6 furnish written proof [of being] that the bidder or a
- 7 subcontractor employed by the bidder, if applicable, is a party
- 8 to a registered apprenticeship agreement for each apprenticeable
- 9 trade the bidder or the subcontractor will employ to construct
- 10 the public works and, if awarded the contract, shall continue to
- 11 certify monthly in writing that the bidder or subcontractor, if
- 12 applicable, is a party to a registered apprenticeship agreement
- 13 for each apprenticeable trade the bidder or subcontractor will
- 14 employ to construct the public works for the entire duration of
- 15 the bidder's work on the project. This subsection shall be
- 16 deemed to be incorporated into a public works contract. A
- 17 bidder who is awarded a contract shall be subject to the
- 18 following sanctions if, after commencement of work, the bidder
- 19 or a subcontractor employed by the bidder at any time during the
- 20 construction is no longer a party to a registered apprenticeship
- 21 agreement for each apprenticeable trade the bidder or the
- 22 subcontractor will employ to construct the public works:

2		project, without recourse to breach of contract claims
3		by the bidder; provided that the governmental body
4		shall be entitled to restitution for nonperformance or
5		liquidated damages, as appropriate; or

7		103D-702.
8	(d)	For purposes of this section[, "bidder"]:
9	<u>"Bid</u>	der" means an entity that submits a competitive sealed
10	bid under	section 103D-302 or submits a competitive sealed
11	proposal	under section 103D-303.
12	<u>"Sub</u>	contractor" means any entity, organization, or
13	individual that enters into, or intends to enter into, a	
14	contract or agreement with a bidder to provide construction	
15	services on a public works project."

17	and stricken. New statutory material is underscored.
