# A BILL FOR AN ACT

RELATING TO LEGISLATIVE CAUCUSES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Each house of the Hawaii state legislature has 2 had a keiki caucus and a kupuna caucus for many years. The keiki caucus, established in December 1990, concentrates on 3 issues concerning the betterment of the lives of children and 4 The kupuna caucus, established in January 2005, 5 youth. 6 concentrates on issues concerning the betterment of lives of elders and grandparents, including aging, long-term care, and 7 8 elder abuse.

The keiki caucus and the kupuna caucus each hold 9 informational legislative meetings and briefings in the interim 10 session to gather information from community groups, from the 11 public in general, and from affected individuals in particular. 12 Government agencies also participate in the meetings and 13 briefings. Oftentimes, issues can be resolved at a meeting or 14 briefing by bringing public awareness to the problem and 15 encouraging dialogue among the parties. The legislature finds 16 that the keiki caucus and kupuna caucus perform an integral 17

1 function of the legislative process of information gathering, problem solving, and making recommendations for change, hearing 2 3 the voice of persons who may otherwise not be heard. 4 The purpose of this Act is to establish the keiki caucus 5 and the kupuna caucus in statute. 6 SECTION 2. The Hawaii Revised Statutes, is amended by 7 adding a new chapter to be appropriately designated and to read 8 as follows: 9 "CHAPTER 10 LEGISLATIVE CAUCUSES 11 S -1 Keiki caucus; kupuna caucus; established. (a) 12 There is established a joint legislative keiki caucus to address 13 issues concerning the well-being, health, safety, and welfare of 14 children and youth. 15 (b) There is established a joint legislative kupuna caucus 16 to address issues concerning the aged and elderly. 17 (C) Membership of the joint legislative keiki caucus and 18 the joint legislative kupuna caucus shall consist of members of 19 both houses of the legislature. In addition, the legislative 20 members of the caucuses may decide to include youth-serving and 21 elderly-serving organization representatives and individuals of

the community as members of the caucus with regard to any 1

particular issue under consideration by the caucus." 2

SECTION 3. This Act shall take effect upon its approval. 3
