A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Once national health care reform legislation
 gains passage, states must be prepared to implement changes to
 existing federal health care programs. This is especially
 crucial given the potential for large-scale change to medicaid
 plans likely to be initiated through such reform legislation.

6 The purpose of this Act is to ensure a continuity of care 7 for Hawaii's neediest population and to make certain that 8 medicaid contracts reflect expectations outlined in national 9 health care reform by establishing restrictions on the issuance 10 of request for proposals for QUEST contracts.

SECTION 2. Section 103F-402, Hawaii Revised Statutes, is
amended by amending subsection (a) to read as follows:

13 "(a) State agencies to which the legislature has 14 appropriated funds for the purchase of health and human services 15 shall solicit proposals to provide health and human services by 16 purchase of health and human services contracts, by publishing a 17 notice requesting the submission of health and human service
