### A BILL FOR AN ACT

RELATING TO FUNDING FOR PARKING FOR DISABLED PERSONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 249-31, Hawaii Revised Statutes, is
amended to read as follows:

"§249-31 State registration fee. (a) All vehicles and 3 4 motor vehicles in the State [as defined in section 249-1], 5 including antique motor vehicles, except as otherwise provided in sections 249-4 and 249-6, shall be subject to a  $[\frac{25}{25}]$  \$26 6 7 annual vehicle registration fee. The fee shall become due and payable on January 1, and shall be paid before April 1 in each 8 year together with all other taxes and fees levied by this 9 10 chapter; provided that should any county elect to renew motor 11 vehicle registrations on a staggered basis as authorized by 12 section 286-51, the state registration for that county shall 13 likewise be staggered so that the state registration fee is due 14 and payable at the same time and shall be collected together 15 with the county fee. The state registration fee shall be deemed 16 delinquent if not paid with the county registration fee. The 17 respective counties shall collect this fee together with the

1 vehicle registration tax collected for the county and shall 2 transfer the moneys collected under this section to the State. 3 (b) From each annual motor vehicle registration fee, the 4 director shall deposit \$20 into the state highway fund [and], \$5 5 into the emergency medical services special fund[-], and \$1 into 6 the disability and communication access board special fund under 7 section 348F-7." 8 SECTION 2. Section 348F-7, Hawaii Revised Statutes, is 9 amended to read as follows: 10 "[+]§348F-7[+] Disability and communication access board 11 special fund. (a) There is established the disability and 12 communication access board special fund to be administered by 13 the disability and communication access board. All moneys 14 received by the disability and communication access board [as 15 application fees for credentialing of interpreters] pursuant to 16 section 249-31 shall be deposited into the special fund. All 17 interest earned or accrued on moneys deposited into this special 18 fund shall become part of the special fund. 19 (b) Moneys in the disability and communication access 20 board special fund shall be expended to cover [all] costs of 21 administering [this chapter including the costs of administering 22 the program for the state credentialing of interpreters.] the 2010-0271 SB SMA.doc
