BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. The purpose of this Act is to require the |

| 7 | amended by adding a new section to be appropriately designated |
| 8 | and to read as follows: |
| 9 | "§302A- Departmental data sharing. (a) The department |
| 10 | of education, the University of Hawaii, and the department of |
| 11 | labor and industrial relations shall share data to support |
| 12 | research that will improve educational and workforce outcomes |
| 13 | and meet the longitudinal data requirements of the federal |
| 14 | American Recovery and Reinvestment Act of 2009, as amended. The |
| 15 | data to be shared shall be determined jointly by the department |
| 16 | of education, the University of Hawaii, and the department of |
| 17 | labor and industrial relations no less than annually. |
