A BILL FOR AN ACT

RELATING TO BICYCLES AND MOPED FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 249-14, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§249-14 Bicycle and moped fee. (a) Bicycles having two
- 4 tandem wheels that are twenty inches or more in diameter and all
- 5 mopeds are required to be registered and shall be subject to a
- 6 permanent registration fee of \$15, to be paid by the owners
- 7 thereof to the director of finance.
- 8 (b) An owner of a bicycle having two tandem wheels that
- 9 are less than twenty inches in diameter is not required to
- 10 register such bicycle, but may do so to facilitate the return of
- 11 recovered stolen bicycles by payment of the registration fee.
- 12 The fee collected shall not be refunded or prorated. Upon
- 13 receipt of the fee, the director of finance shall number and
- 14 register each bicycle and moped for which the fee is paid, in
- 15 the owner's name and furnish the owner with a metallic tag or
- 16 decal for each bicycle or moped which shall be attached to the
- 17 bicycle or moped. On bicycles the decal shall be affixed to the

1	direction.	On	mopeds	the	decal	shall	be	affixed	to	the	lower

- 2 portion of the rear fender facing rearward. Upon initial
- 3 registration by an owner or transferee, the director of finance
- 4 shall require proof of ownership and require the owner to
- 5 furnish verification of the serial number and description
- 6 contained in the proof of ownership and application for
- 7 registration. The metallic tags or decals shall be in a form as
- 8 the director of finance shall from time to time prescribe. It
- 9 shall be the duty of the director of finance of each county to
- 10 purchase a sufficient number of these tags or decals.
- 11 (c) All fees collected under this section shall be
- 12 deposited into the bikeway fund and shall be expended in the
- 13 county in which the fees are collected as provided in section
- **14** 249-17.5.
- 15 (d) Any person who violates subsection (a) shall be fined
- 16 not more than \$500."
- 17 SECTION 2. New statutory material is underscored.
- 18 SECTION 3. This Act shall take effect upon its approval.
