## A BILL FOR AN ACT

RELATING TO WITNESSES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the per diem stipend 2 amount for out-of-state witnesses has remained static for a 3 number of years. This amount is no longer sufficient to pay the 4 personal expenses of out-of-state witnesses, such as lodging and food. Often these individuals are forced to take money out of 5 6 their own pockets to cover necessary personal expenses when 7 subpoenaed to return to the State as a witness in state court 8 proceedings. Because the per diem stipend amount has not been 9 adjusted to keep pace with the cost of living in Hawaii, it has 10 emerged as an economic "barrier" that either discourages or 11 prevents an out-of-state witness from pursuing charges against 12 offenders due to economic considerations. Further, the legislature also finds that the per diem stipend amount for 13 14 witnesses that are required to travel to a different island is 15 also not sufficient to cover the witness' personal expenses when 16 that witness is required to stay overnight.

17 The purpose of this Act is to increase the amount of per

1 travel, plus \$55 per twenty-four-hour day[, which 2 amounts]; 3 provided that when the witness is required to stay overnight, 4 the witness shall be entitled to an additional \$90 per twenty-5 four-hour day. These per diem payments shall cover all personal 6 expenses, such as board and lodging[. These per diem payments] 7 and shall be computed on the basis of quarter day periods of 8 time." 9 SECTION 3. Statutory material to be repealed is bracketed 10 and stricken. New statutory material is underscored. 11 SECTION 4. This Act shall take effect on July 1, 2050. 12

## Report Title:

Witness in Criminal Cases; Per Diem Payments

## Description:

Increases the per diem payments for out-of-state witnesses in criminal cases from \$110 to \$145. Provides an additional \$90 per diem payment for witnesses from any island other than the island on which the court is located, when that witness is required to stay overnight. Effective July 1, 2050. (SD1)
