A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 249-2, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§249-2 Imposition of tax. Except as otherwise provided
4	in sections 249-1 to 249-13, and except in the case of antique
5	motor vehicles which shall be subject to an annual tax of \$10 in
6	lieu of the annual tax otherwise imposed by this section, all
7	vehicles and motor vehicles as defined in section 249-1, shall
8	be subject to an annual tax, computed, except for the minimum
9	tax provided for in section 249-13 according to the net weight
10	of each vehicle at a rate determined as hereinafter provided in
11	section 249-13. [The tax shall become due and payable on
12	January 1 and must be paid before April 1, in each year.] The
13	tax shall be paid by the owner of each vehicle in the county in
14	which the vehicle is located at the time of registration,
15	whether the original registration or any subsequent
16	registration, and shall be collected by the director of finance
17	of such county; provided that if [any such] a vehicle is
18	transported to another county after the payment of [such] the

Section 249-33, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 The tax shall become due and payable [on January 1 and shall be paid before April 1] in each year together with all 4 5 other taxes and fees levied by this chapter[; provided that 6 should any county elect to renew motor vehicle registrations] on 7 a staggered basis as established by each county as authorized by 8 section 286-51, the state vehicle weight tax shall likewise be 9 staggered so that the state vehicle weight tax is collected 10 together with the county fee. The state vehicle weight tax 11 shall be deemed delinquent if not paid with the county 12 registration fee. The tax shall be paid by the owner of each 13 vehicle to the director of finance of the county in which the 14 vehicle is registered and shall be collected by the director of 15 finance of such county together with all other fees and taxes 16 levied by this chapter from the owner of each vehicle and motor 17 vehicle registered in the county. 18 By the fifteenth day of the month following the month in 19 which taxes under this section are collected, the director of 20 finance of each county shall transmit the taxes collected to the 21 state director of finance for deposit into the state highway
