A BILL FOR AN ACT

RELATING TO PUBLIC MEETINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that providing a breadth 2 of opportunities for board members to learn is fundamental to 3 the board members' effective decisionmaking. The legislature further finds that conferences, seminars, and other training 4 5 programs provide opportunities for board members to learn, 6 receive information, clarify situations or misinformation, and be exposed to a range of ideas, facts, and information, which 7 8 are essential to their duties and responsibilities as board 9 members.

10 The purpose of this Act is to enable members of a board to participate in discussions at functions organized and conducted 11 12 by entities other than the board, provided that: (1) No 13 commitment to vote and no position is made or sought by any of 14 the attending board members on any matter related to official 15 board business; and (2) At the next meeting of the board, board 16 members report their attendance at the function and the matters 17 presented and discussed at the function that relate to official

18 board business.

1	SECTION 2. Section 92-2.5, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§92-2.5 Permitted interactions of members. (a) Two
4	members of a board may discuss between themselves matters
5	relating to official board business to enable them to perform
6	their duties faithfully, as long as no commitment to vote is
7	made or sought and the two members do not constitute a quorum of
8	their board.
9	(b) Two or more members of a board, but less than the
10	number of members which would constitute a quorum for the board,
11	may be assigned to:
12	(1) Investigate a matter relating to the official business
13	of their board; provided that:
14	(A) The scope of the investigation and the scope of
15	each member's authority are defined at a meeting
16	of the board;
17	(B) All resulting findings and recommendations are
18	presented to the board at a meeting of the board;

20	(C) Deliberation and decisionmaking on the matter
21	investigated, if any, occurs only at a duly
22	noticed meeting of the board held subsequent to

4	(2)	Present, discuss, or negotiate any position which the
5		board has adopted at a meeting of the board; provided
6		that the assignment is made and the scope of each
7		member's authority is defined at a meeting of the
8		board prior to the presentation, discussion <u>,</u> or
9		negotiation.
10	(c)	Discussions between two or more members of a board,
11	but less	than the number of members which would constitute a
12	quorum fo	r the board, concerning the selection of the board's

12 quorum for the board, concerning the selection of the board's 13 officers may be conducted in private without limitation or 14 subsequent reporting.

(d) Discussions between the governor and one or more members of a board may be conducted in private without limitation or subsequent reporting; provided that the discussion does not relate to a matter over which a board is exercising its adjudicatory function.

22 assigned may be conducted in private without limitation;
