A BILL FOR AN ACT

RELATING TO LONG TERM CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The long term care commission, established by 2 Act 224, Session Laws of Hawaii 2008, has reported that it is 3 unable to meet its reporting deadlines to the legislature of 4 February 28, 2010, and September 30, 2010, due to a lack of 5 funding. The long term care commission is set to expire on 6 November 30, 2010. Delays in obtaining the funds necessary to 7 support the work of the commission made it impossible to meet 8 the reporting dates specified in Act 224. In time, funding from 9 non-state sources was secured and a work plan was adopted by the 10 commission, but with new interim and final reporting dates. The 11 commission believes the interim report called for by Act 224 can 12 be timely submitted to the 2011 legislature, and the final 13 report called for by Act 224 can be timely submitted to the 2012 14 legislature.

15 The purpose of this Act is to extend the sunset of the long 16 term care commission and its reporting deadlines to the 17 legislature.
