A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended 1
- by adding a new section to be appropriately designated and to 2
- read as follows: 3
- "§11- Elections commission; direct recourse to the 4
- supreme court. The elections commission, through its chief 5

- SECTION 2. Section 11-2, Hawaii Revised Statutes, is 13

- election officer shall supervise all state elections. The chief 16

- 1 elections within a county to the clerk of that county or to

- 3 (b) The chief election officer shall be responsible for
- 4 the maximization of registration of eligible electors throughout
- 5 the State. In maximizing registration, the chief election
- 6 officer shall make an effort to equalize registration between
- 7 districts, with particular effort in those districts in which
- 8 the chief election officer determines registration is lower than
- 9 desirable. The chief election officer, in carrying out this
- 10 function, may make surveys, carry on house-to-house canvassing,
- 11 and assist or direct the clerk in any other area of
- 12 registration.
- 13 (c) The chief election officer shall maintain data
- 14 concerning registered voters, elections, apportionment, and
- 15 districting. The chief election officer shall use this data to
- 16 assist the reapportionment commission provided for under Article

Increases the duties of the elections commission to include supervision over the chief election officer. Contingent upon ratification of constitutional amendment.
