# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that economic downturns
2	cause governments and businesses alike to operate within smaller
3	budgets and limit the provision of services or goods to those
4	that are most basic and essential to fulfilling the agency or
5	firm's mission, duties, and responsibilities. The legislature
6	finds that the department of education must similarly find ways
7	to narrow the scope of its operations in the long-term by
8	identifying those non-core programs that would not compromise
9	the department's basic and essential functions if eliminated and
10	by closing underutilized schools before opening new schools.
11	The purpose of this Act is to improve the efficiency of the
12	department of education by:
13	(1) Requiring the department to periodically review all
14	non-core programs under the department, alternative
15	funding mechanisms or sources for those non-core
16	programs, and report to the legislature its findings
