A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR THE DEPARTMENT OF HUMAN SERVICES TO ADDRESS THE BUDGET SHORTFALL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I 2 This part is recommended by the governor for SECTION 1. 3 immediate passage in accordance with section 9 of article VII of 4 the Constitution of the State of Hawaii. 5 SECTION 2. The legislature finds that a critical funding emergency exists. The general assistance program is a block 6 grant program, and the maximum allowance a general assistance 7 8 recipient may receive is determined by dividing the amount of the appropriation by the number of general assistance 9 10 recipients. The general assistance program will expend all 11 appropriated funds before the end of the current fiscal year and 12 the department will be unable to maintain the current maximum 13 general assistance payment benefit. 14 The legislature finds that the current assistance grant for 15 disabled persons is barely enough to cover living expenses for persons on a fixed income who have no other viable means of 16 support. Stopping the grant payment or reducing the amount of

- 1 the grant payment for these persons poses a real threat to these
- 2 their health and safety. To prevent the reduction of general
- 3 assistance payments in the third and fourth quarters of fiscal
- 4 year 2009-2010, additional funds are urgently needed.
- 5 The purpose of this part is to appropriate additional
- 6 general funds to address expenses related to general assistance
- 7 payments from the department of human services.
- 8 SECTION 3. Notwithstanding any other law to the contrary,
- 9 there is appropriated out of the general revenues of the State
- 10 of Hawaii, the sum of \$\\$ or so much thereof as may be
- 11 necessary for the purpose of making general assistance payments
- 12 for the months of January to June, 2010.
- 13 SECTION 4. The sum appropriated shall be expended by the
- 14 department of human services for the purposes of this part.
- 15 PART II
- 16 SECTION 5. If any provision of this Act, or the
- 17 application thereof to any person or circumstance is held
- 18 invalid, the invalidity does not affect other provisions or
- 19 applications of the Act, which can be given effect without the
- 20 invalid provision or application, and to this end the provisions
- 21 of this Act are severable.
