A BILL FOR AN ACT

RELATING TO SALARIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that existing laws
authorize the board of education to set the salaries of the
superintendent of education, deputy superintendent, assistant
superintendents, complex area superintendents, and state
librarian. The salaries of the deputy superintendent, assistant
superintendents, and complex area superintendents are capped by
statute at a percentage of the superintendent's salary.

8 The legislature further finds that it is a challenge to 9 recruit and fill state and complex area leadership positions 10 because the maximum salaries are not competitive with or in the 11 range of the salaries of other administrative leadership 12 positions at the school level. The cap on the superintendent's 13 salary was last established in 2000, and the cap on the state 14 librarian's salary was last established in 2001.

15 The legislature finds that amending the current salary caps 16 for the superintendent of education and state librarian would 17 provide the board of education with the authority and latitude 18 to establish the salaries of these leadership positions SB2434 HD1 HMS 2010-2656 Page 2

1	commensurate with various factors, including the breadth of
2	responsibilities and duties of those positions and the
3	experience and skills the individuals bring to their respective
4	positions. Adjusting the salary caps would also provide the
5	board of education with the flexibility it needs to attract and
6	retain individuals to support a strong statewide public
7	education system and statewide public library system.
8	The purpose of this Act is to provide the board of
9	education, as the appointing authority for the superintendent
10	and state librarian, with more flexibility to establish the
11	salaries of the superintendent and state librarian by adjusting
12	the salary caps on these state leadership positions.
13	SECTION 2. Section 26-52, Hawaii Revised Statutes, is
14	amended to read as follows:
15	"§26-52 Department heads and executive officers. The
16	salaries of the following state officers shall be as follows:
17	(1) The salary of the superintendent of education shall be
18	set by the board of education at a rate no greater
19	than [\$150,000-a year;] one hundred fifty per cent of
20	the highest salary for a principal based on the salary
21	schedule included in the most recent collective
22	bargaining agreement;

4	SECTION 3. Section 312-2.1, Hawaii Revised Statutes, is
5	amended by amending subsection (b) to read as follows:

7	board of education at a rate no greater than [\$120,000 a year.]
8	one hundred fifty per cent of the salary of the highest-paid
9	librarian in the department of education."
10	SECTION 4. Statutory material to be repealed is bracketed
11	and stricken. New statutory material is underscored.
12	SECTION 5. This Act shall take effect on July 1, 2020, and
13	shall apply beginning with the 2011-2012 school year.
