A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE SUN SCREENING DEVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-21.5, Hawaii Revised Statutes, is 2 amended by amending subsection (d) to read as follows: 3 "(d) This section shall not apply to: Rearview mirrors; 4 (1) 5 Adjustable nontransparent sun visors which are mounted (2) 6 forward of the side windows and are not attached to 7 the glazing material; 8 (3) Signs, stickers, or other materials which are 9 displayed in a seven-inch square in the lower corner of the windshield farthest removed from the driver or 10 11 signs, stickers, or other materials which are 12 displayed in a five-inch square in the lower corner of the windshield nearest the driver; 13 14 Rear trunk lid handle or hinges; (4) 15 Window wipers and window wiper motors; (5) 16 (6) Transparent sun screening film materials which are **17** installed, affixed, or applied along the top edge of

1		the windshield so long as such materials do not
2		encroach upon the AS-1 portion of the windshield as
3		provided by the Federal Motor Vehicle Safety Standards
4		205 or no lower than four inches below the top of the
5		windshield, when measured from the middle point of the
6		bottom edge of the top windshield moulding if no AS-1
7		markings can be found in the left or right upper
8		margin of the windshield;
9	(7)	Sun screening devices for front side wing vents and
10		windows which, when used in conjunction with the
11		glazing material have a light transmittance of no less
12		than thirty-five per cent plus or minus six per cent;
13	(8)	Sun screening devices for side windows necessary for
14		driving visibility which are to the rear of the driver
15		and for rear windows necessary for driving visibility
16		which, when used in conjunction with the glazing
17		material, have a light transmittance of no less than
18		thirty-five per cent plus or minus six per cent;
19	(9)	Side windows which are to the rear of the driver and
20		rear windows on vans, minivans, trucks, or buses;
21		provided that the vehicles are equipped with rearview
22		mirrors on both sides;
