A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that although motor
2	vehicle rental concessions at Hawaii's public airports
3	contribute over \$30,000,000 a year in concession revenues to

- 4 support Hawaii's public airports, the legislature in 2008
- 5 recognized that no facility improvements to those concessions
- 6 would be made considering other airport priorities as to the use
- 7 of the funds. Thus, in spite of years of discussions, the
- 8 facilities over time have deteriorated and have not kept pace
- 9 with motor vehicle rental facilities and services provided to
- 10 visitors and residents at other public airports across the
- 11 United States.
- 12 As a result, the legislature in 2008 passed Act 226,
- 13 Session Laws of Hawaii (Act 226) 2008, which established a
- 14 rental motor vehicle customer facility charge program similar to
- 15 programs at more than one hundred other airports across the
- 16 United States. Act 226 established a rental motor vehicle
- 17 customer facility charge of \$1 per day. Act 226 also
- appropriated \$10,000,000 for planning, design, and some SB2461 HD2 HMS 2010-2959



- 1 improvements. Recognizing the importance of the program to
- 2 Hawaii's construction industry and economy, the legislature
- 3 required the department of transportation to provide annual
- 4 reports and timelines to ensure the "fast-tracking" of the
- 5 facility projects and services.
- 6 The department has sought to fast-track the program in
- 7 keeping with the legislative directive and, with the assistance
- 8 of planners, designers, and other consultants, has completed
- 9 initial designs and plans for the statewide program. The intent
- 10 of this Act is to continue the fast-tracking by:
- 11 (1) Taking the program to the next level by increasing the
- rental motor vehicle customer facility charge to \$4.50
- daily as recommended by consultants; and
- 14 (2) Making further appropriations to support the program,
- including the construction of a \$230,000,000
- 16 consolidated facility at Honolulu international
- airport and an overflow vehicle storage facility at
- 18 Kahului airport.
- 19 According to reports prepared by consultants, the increased
- 20 charge of \$1 daily to \$4.50 daily is expected to fund the
- 21 planned statewide program with no anticipated future increases.
- 22 This fee and one-time step up is comparable to similar charges

- 1 and programs at other airports. Delayed generation of revenues
- 2 by stepping up these charges as proposed by some could likely
- 3 result in the fee rising higher than \$5 daily, a scenario which
- 4 must be avoided.
- 5 The charge of \$4.50 daily and revenues generated will
- 6 strongly support the program as well as the bonds to finance the
- 7 related construction projects, which will total about
- 8 \$500,000,000, excluding finance charges. To avoid program
- 9 delays, it is very important that the program have strong
- 10 financing and a stream of revenues to attract the buyers of the
- 11 bonds during these turbulent economic times. The one-time-
- 12 increased charge, as opposed to stepped-up charges, will also
- 13 result in as much as \$300,000,000 saved in finance costs. By
- 14 fast-tracking the projects, it is anticipated that the program
- 15 will benefit from about thirty per cent to forty per cent in
- 16 construction cost savings.
- 17 As reported by consultants, the increased charge to \$4.50
- 18 daily is expected to have no adverse impact on rental motor
- 19 vehicles at public airports or on public airport revenues.
- 20 Other cities and airports have studied similar concerns and the
- 21 studies have repeatedly found no correlation or adverse impact
- 22 related to an increased charge. In fact, airports generally

- 1 have seen an increase in revenues since the facilities attract
- 2 motor vehicle rental companies to conduct their business at the
- 3 airport.
- 4 The program does not require visitors and residents to rent
- 5 a car at a public airport. Individuals will have the
- 6 opportunity to rent vehicles from off-airport locations and
- 7 thereby avoid having to pay the rental motor vehicle customer
- 8 facility charge. To minimize the impact to travel agents and
- 9 others marketing travel packages and quoting prices, this
- 10 measure delays implementation of the increased rental motor
- 11 vehicle customer facility charge until September 1, 2010.
- 12 While the goal of fast-tracking was to start the
- 13 construction of the Honolulu international airport facility as
- 14 early as the first quarter of 2010 and thereby provide critical
- 15 jobs and support for Hawaii's economy, the failure to date of
- 16 increasing the charge to \$4.50 daily has delayed the
- 17 implementation of this start date as well as any related sale of
- 18 bonds. Although this Act provides that the department has the
- 19 discretion to raise and adjust the rental motor vehicle customer
- 20 facility charge to meet the program's goals notwithstanding any
- 21 law to the contrary, the department recently commented that the
- 22 law needs to be clarified and that it cannot increase charges

- 1 without proceeding through the rules process, which could take
- 2 twelve months or longer. The legislature finds that it is
- 3 preferable that it mandate the increase in charges so such
- 4 minimum amount of customer facility charge fees, as recommended
- 5 by the consultants, are collected by the department no later
- 6 than September 1, 2010, to avoid and ensure that there are no
- 7 further delays to the program if the department is not
- 8 collecting the minimum customer facility charge fees by that
- 9 date.
- 10 The intent of this Act is to continue the fast-tracking of
- 11 this program and its projects, thereby providing critical jobs
- 12 to Hawaii's residents and stimulating Hawaii's suffering economy
- 13 by:
- 14 (1) Raising the initial rental motor vehicle customer
- facility charge, as established by Act 226, Session
- 16 Laws of Hawaii 2008, from \$1 daily to \$4.50 daily as
- 17 recommended by consultants, so that the strength of
- the program can be maintained and the program can
- benefit from various anticipated costs savings;
- 20 (2) Removing the initial collection ceiling of \$25,000,000
- so in excess of \$500,000,000 of construction and
- finance costs can be collected to fund and support

1		projects based upon consultant estimates and reports	
2		provided to date;	
3	(3)	Clarifying that the department of transportation can	
4		adjust the rental motor vehicle customer facility	
5		charge for companies without a concession at a state	
6		airport without having to establish rules, as recently	
7		reported by the department; and	
8	(4)	Appropriating \$ out of the rental motor	
9		vehicle customer facility charge special fund for the	
10		program for its continued fast-tracking of projects,	
11		including the construction of projects at Honolulu	
12		international airport and Kahului airport.

- 4 airports, including:
- (1) Acquisition and maintenance of property or property
 rights for rental motor vehicle purposes;
- 7 (2) Acquisition of equipment for and operation of a
 8 unified shuttle bus system to and from passenger
 9 terminals and the rental motor vehicle customer
 10 facilities;
- 11 (3) Consultant fees;
- 12 (4) Management, operation, and maintenance fees for rental

 13 motor vehicle customer facilities; and
- 14 (5) Conceptual plans, plans, design, construction,
 15 operation, and maintenance of, or allocable to, the
 16 approved rental motor vehicle customer facilities and

- 18 In planning the future needs and expenditures of these moneys,

- 1 design, improve, enhance, acquire, or construct rental motor
- 2 vehicle customer facilities, equipment, or services shared or to
- 3 be shared by rental motor vehicle concessions at a state airport

- 1 SECTION 3. Section 261-7, Hawaii Revised Statutes, is 2 amended by amending subsection (h) to read as follows: 3 "(h) Notwithstanding any laws to the contrary, the 4 department may establish, levy, assess, and collect rental motor 5 vehicle customer facility charges[, which] without regard to 6 chapter 91, which shall be paid to the department periodically 7 as determined by the department[. These charges] and shall be 8 used to pay for, or finance on a long-term basis or other-term 9 basis where appropriate, the design, planning, construction, and other uses of the rental motor vehicle customer facility charges 10 11 as set forth by the rental motor vehicle customer facility 12 charge special fund in section 261-5.6. 13 The rental motor vehicle customer facility charges shall be 14 levied, assessed, and collected from all rental motor vehicle 15 customers who benefit from the use of any type of rental motor 16 vehicle facility or service provided by the department at a 17 state airport. 18 Beginning September 1, 2010, the department shall levy, 19 assess, and collect a rental motor vehicle customer facility 20 charge of \$4.50 per day, or any portion of a day that a rental motor vehicle is rented or leased, by a rental motor vehicle 21 22 concession where customers pick up and return rental vehicles to
