A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. In 1999, the legislature established the emergency and budget reserve fund as a temporary supplemental 2 3 source of funding for the State of Hawaii in times of emergency, 4 economic downturn, or unforeseen reduction in revenues. As set 5 forth in section 328L-3, Hawaii Revised Statutes, specific 6 purposes for the fund include the maintaining of levels of 7 programs determined to be essential to public health, safety, 8 welfare, and education. 9 The legislature finds that the national and global economic 10 crisis has caused significant economic problems in numerous 11 industries in the state, including the airline, cruise ship, 12 tourist, and construction industries. Mass layoffs have been reported by an increasing number of Hawaii businesses statewide, 13 14 from the agricultural sector to the medical services sector.

15 Hawaii's automobile dealers have cut fifteen per cent of their 16 workforce and that percentage could double in the future.

17 Financial uncertainty has caused decreased visitor arrivals and

employee hours. Furthermore, recent forecasts show that the
 situation will worsen with a continued decline in jobs, personal
 income, and visitor arrivals, and with rising inflation.

4 Difficult economic times and declining tax revenues have 5 resulted in budget cuts for all state services. State departments have been asked to lower their budget proposals by 6 up to twenty per cent. The department of education faces a 7 possible \$70,000,000 shortfall for the next academic year and 8 9 funding has discontinued for science textbooks and materials, programs for literacy training for learning-disabled children, 10 11 as well as for speech pathologists, occupational, and physical therapists, and more than two hundred other positions. 12

The department of health has projected a \$25,000,000 13 shortfall for mental health services and a \$5,400,000 shortfall 14 for developmental disabilities services in the current fiscal 15 year. Funding has been eliminated for the healthy start 16 17 program, totaling approximately \$22,000,000 for the biennium. Additionally, the governor has discontinued funding for the 18 Hawaii children's health care program, which may leave an 19 estimated one thousand five hundred gap group children without 20 21 access to affordable health care.

1 The current and impending situation jeopardizes the safety 2 net of basic human services, health, and education needs for 3 Hawaii's residents and families. And while all of Hawaii's 4 residents will be affected by the situation, gap group families 5 and families closest to the poverty line will suffer the most. 6 The legislature finds that expenditures from the emergency 7 and budget reserve fund established by section 328L-3, Hawaii 8 Revised Statutes, are needed to meet the conditions of 9 emergency, economic downturn, and unforeseen reduction in 10 revenues that the State currently faces. Further, the 11 legislature finds that the appropriations in this Act are consistent with the purposes of the emergency and budget reserve 12 13 fund.

14 The purpose of this Act is to appropriate moneys from the 15 emergency and budget reserve fund of the State of Hawaii to 16 maintain the levels of programs determined to be essential to 17 education, public health, and public welfare.

18 SECTION 2. There is appropriated out of the emergency and 19 budget reserve fund of the State of Hawaii the sum of \$463,340 20 or so much thereof as may be necessary for fiscal year 2010-2011 21 for respite services.



The sum appropriated shall be expended by the department of
 health for the purposes of this Act.

3 SECTION 3. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$4,000,000
5 or so much thereof as may be necessary for fiscal year 2010-2011
6 to supplement the healthy start program.

7 The sum appropriated shall be expended by the department of8 health for the purposes of this Act.

9 SECTION 4. There is appropriated out of the emergency and
10 budget reserve fund of the State of Hawaii the sum of \$470,000
11 or so much thereof as may be necessary for fiscal year 2010-2011
12 to provide funding for grants pursuant to chapter 42F, Hawaii
13 Revised Statutes, to be distributed as follows:

14	(1)	Catholic Charities Hawaii	\$200,000
15	(2)	Kapahulu Center	\$100,000
16	(3)	Moiliili Community Center	\$ 50,000
17	(4)	Waikiki Community Center	\$120,000

18 The sum appropriated shall be expended by the department of 19 health for the purposes of this Act.

20 SECTION 5. There is appropriated out of the emergency and
21 budget reserve fund of the State of Hawaii the sum of \$2,963,411



or so much thereof as may be necessary for fiscal year 2010-2011
 for the purposes of maintaining kupuna care services.

3 The sum appropriated shall be expended by the department of4 health for the purposes of this Act.

SECTION 6. There is appropriated out of the emergency and
budget reserve fund of the State of Hawaii the sum of \$220,000
or so much thereof as may be necessary for fiscal year 2010-2011
for the Aging and Disability Resource Center.

9 The sum appropriated shall be expended by the department of10 health for the purposes of this Act.

SECTION 7. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$7,000,000 or so much thereof as may be necessary for fiscal year 2010-2011 for the developmental disabilities medicaid waiver program.

15 The sum appropriated shall be expended by the department of 16 health for the purposes of this Act.

SECTION 8. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$13,000,000 or so much thereof as may be necessary for fiscal year 2010-2011, for mental health services.

21 The sum appropriated shall be expended by the department of22 health for the purposes of this Act.



1 SECTION 9. There is appropriated out of the emergency and 2 budget reserve fund of the State of Hawaii the sum of \$500,000 3 or so much thereof as may be necessary for fiscal year 2010-2011, for the partnerships in community living program. 4 5 The sum appropriated shall be expended by the department of 6 health for the purposes of this Act. 7 SECTION 10. There is appropriated out of the emergency and 8 budget reserve fund of the State of Hawaii the sum of \$3,500,000 9 or so much thereof as may be necessary for fiscal year 2010-2011 10 for direct health care to the uninsured, which may include 11 primary medical, dental, and behavioral health care. 12 The sum appropriated shall be expended by the department of 13 health for the purposes of this Act. 14 SECTION 11. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii, as a substance abuse 15 prevention and treatment block grant, the sum of \$2,400,000 or 16 17 so much thereof as may be necessary for fiscal year 2010-2011 18 for substance abuse treatment. 19 The sum appropriated shall be expended by the department of 20 health for the purposes of this Act.

21 SECTION 12. There is appropriated out of the emergency and
22 budget reserve fund of the State of Hawaii the sum of \$250,000

or so much thereof as may be necessary for fiscal year 2010-2011
 for the healthy aging partnerships program.

3 The sum appropriated shall be expended by the department of4 health for the purposes of this Act.

SECTION 13. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$332,000 or so much thereof as may be necessary for fiscal year 2010-2011 for the Waianae Coast Comprehensive Health Center to support financial losses for its emergency room services.

10 The sum appropriated shall be expended by the department of11 health for the purposes of this Act.

12 SECTION 14. There is appropriated out of the emergency and 13 budget reserve fund of the State of Hawaii as a grant pursuant 14 to chapter 42F, Hawaii Revised Statutes, the sum of \$550,000 or 15 so much thereof as may be necessary for fiscal year 2010-2011 16 for the Hawaii immigrant health initiative program.

17 The sum appropriated shall be expended by the department of18 human services for the purposes of this Act.

19 SECTION 15. There is appropriated out of the emergency and 20 budget reserve fund of the State of Hawaii the sum of \$600,000 21 or so much thereof as may be necessary for fiscal year 2010-2011 22 for the Hawaii children's health care program.



The sum appropriated shall be expended by the department of
 human services for the purposes of this Act.

3 SECTION 16. There is appropriated out of the emergency and
4 budget reserve fund of the State of Hawaii the sum of \$762,500
5 or so much thereof as may be necessary for fiscal year 2010-2011
6 for domestic violence shelters.

7 The sum appropriated shall be expended by the department of8 human services for the purposes of this Act.

9 SECTION 17. There is appropriated out of the emergency and
10 budget reserve fund of the State of Hawaii the sum of \$233,280
11 for fiscal year 2010-2011 for the Hale Mahaolu Adult program for
12 personal care services.

13 The sum appropriated shall be expended by the department of 14 human services for the purposes of this Act.

15 SECTION 18. There is appropriated out of the emergency and 16 budget reserve fund of the State of Hawaii the sum of \$8,400,000 17 or so much thereof as may be necessary for fiscal year 2010-2011 18 for disproportionate share hospital costs.

19 The sum appropriated shall be expended by the department of20 human services for the purposes of this Act.

SECTION 19. There is appropriated out of the emergency and
budget reserve fund of the State of Hawaii the sum of \$7,000,000



or so much thereof as may be necessary for fiscal year 2010-2011
 for medicaid provider reimbursements.

3 The sum appropriated shall be expended by the department of4 human services for the purposes of this Act.

SECTION 20. There is appropriated out of the emergency and
budget reserve fund of the State of Hawaii the sum of \$300,000
or so much thereof as may be necessary for fiscal year 2010-2011
for outstationed eligibility worker services.

9 The sum appropriated shall be expended by the department of10 human services for the purposes of this Act.

SECTION 21. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$40,525 or so much thereof as may be necessary for fiscal year 2010-2011 for outreach services.

15 The sum appropriated shall be expended by the department of 16 human services for the purposes of this Act.

SECTION 22. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$164,000 or so much thereof as may be necessary for fiscal year 2010-2011 for outreach services to locate uninsured children.

21 The sum appropriated shall be expended by the department of22 human services for the purposes of this Act.

There is appropriated out of the emergency and 2 budget reserve fund of the State of Hawaii the sum of \$125,000 3 or so much thereof as may be necessary for fiscal year 2010-2011 4 for outreach services to locate uninsured adults. 5 The sum appropriated shall be expended by the department of 6 human services for the purposes of this Act. 7 SECTION 24. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$420,595 8 or so much thereof as may be necessary for fiscal year 2010-2011 9 10 for housing placement services. 11 The sum appropriated shall be expended by the department of 12 human services for the purposes of this Act. 13 SECTION 25. There is appropriated out of the emergency and 14 budget reserve fund of the State of Hawaii the sum of \$500,000 15 or so much thereof as may be necessary for fiscal year 2010-2011 16 for the shelter plus care program. The sum appropriated shall be expended by the department of 17 human services for the purposes of this Act. 18

19 SECTION 26. There is appropriated out of the emergency and
20 budget reserve fund of the State of Hawaii the sum of \$500,000
21 or so much thereof as may be necessary for fiscal year 2010-2011
22 for the Oahu safe house program.



1 The sum appropriated shall be expended by the department of 2 human services for the purposes of this Act. 3 SECTION 27. There is appropriated out of the emergency and 4 budget reserve fund of the State of Hawaii the sum of 5 Ś or so much thereof as may be necessary for fiscal 6 year 2010-2011 for adult dental services. 7 The sum appropriated shall be expended by the department of 8 human services for the purposes of this Act. 9 SECTION 28. There is appropriated out of the emergency and 10 budget reserve fund of the State of Hawaii the sum of 11 or so much thereof as may be necessary for fiscal \$ 12 year 2010-2011 for medicaid. 13 The sum appropriated shall be expended by the department of 14 human services for the purposes of this Act. 15 SECTION 29. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of 16 17 or so much thereof as may be necessary for fiscal \$ 18 year 2010-2011 for child care. 19 The sum appropriated shall be expended by the department of 20 human services for the purposes of this Act. SECTION 30. There is appropriated out of the emergency and 21 22 budget reserve fund of the State of Hawaii the sum of 2010-0623 SB SMA.doc 11

16 The sum appropriated shall be expended by the judiciary for 17 the purposes of this Act.

SECTION 33. There is appropriated out of the emergency and budget reserve fund of the State of Hawaii the sum of \$720,000 or so much thereof as may be necessary for fiscal year 2010-2011 for the Legal Aid Society of Hawaii to provide general civil legal services.

7 SECTION 41. This Act shall take effect on July 1, 2010.
